#### CALL MEETING TO ORDER

Colleen Grady called the meeting to order at 10:33 a.m. With eight members present, a quorum was present.

#### **ELECTION OF COUNCIL OFFICERS**

Colleen Grady provided an agenda overview and clarification of agency priorities which include literacy, learning acceleration, student wellness, and workforce readiness.

Grady called for a nomination of the Chair for the council. Cris Gulacy-Worrel nominated John Hagan for Chair. The motion was seconded by Dave Cash. There being no additional nominations and no opposition, John Hagan was declared to be the Council Chair.

Mr. Hagan assumed chair of the Council meeting.

Mr. Hagan called for nominations for Vice Chair. Lenny Shafer nominated Cris Gulacy-Worrel as Vice Chair. There being no other nominations or opposition, Cris Gulacy-Worrel was declared to be Vice Chair.

William Watson nominated Dave Cash as Secretary. There being no other nominations or opposition, Dave Cash was declared to be the Council Secretary.

### ADOPTION OF BYLAWS AND REVIEW OF COUNCIL CHARGE

Lenny Schafer made a motion to approve the bylaws. William Watson seconded the motion. The bylaws were adopted with no opposition.

- Representing a variety of stakeholders to communicate interests and concerns of the dropout prevention and recovery community;
- Promoting the identification of best practices for dropout prevention and recovery schools;
- Making recommendations to the Department regarding legislative changes related to dropout prevention and recovery schools.

## DROPOUT PREVENTION AND RECOVERY RULES AND GUIDANCE

Colleen Grady provided an overview of the dropout recovery report card and presented on OAC 3301-102-10 through 12. There were no questions from the council.

### DISCUSSION

- 2. Discussion of workforce programs and options for schools.

- 4. Information related to the Ohio Backpack Bill. Is there a correlation between the bill and enrollment increases in dropout prevention and recovery community schools.
- 5. Labor market for the 16-24 age group.
