# 3314.016

- Specifies the requirement re: evaluation and requirements for sponsors rated as ineffective.
- RC 3314.016 (B)(7)(b)(i) requires that "sponsors rated as ineffective shall be subject to a quality improvement plan with timelines and benchmarks established by the department."

Meet statutory requirement

Provide Guidance and support to sponsors

Improve sponsor performance

# **Plan Requirements**

Address all deficiencies

Include goals and actions

**Be specific** 

**Be realistic** 

Time period cannot exceed 2 years
