Report Overview

General Description and Significance

This exception report provides a listing of preschool special education and non special education students who should have a PRESCHOOL GGG ASSESSMENT record but it has not yet been reported by the district. These students meet the profile described under selection criteria.

These data define whether or not all preschool students without disabilities, ages 3-5 as of December 1, enrolled in a preschool program funded or administered by the Office of Early Learning and School Readiness (EL&SR) have been assessed using this instrument.

These data also define whether all preschool students with disabilities age 3-5 by December 1 and grade level PS who receive preschool education and/or related services have been assessed using this instrument regardless of the funding source or type of service provided.

Report Distribution

A report is to be distributed weekly to any EMIS reporting entity where data meet the report criteria. It is to be generated during the weekly cycle and transferred to its contracted ITC for distribution. The output is to include district-level information in a single report file.



Report Selection Criteria: Potential Students

FISCAL YEAR is the current school year and reporting period is October (K) or Yearend (N).

The grade level used must be the grade level equal (STATE EQUIVALENT GRADE LEVEL) equal to "PS."

Any preschool student between the age of 3-5 years as of December 1 of the current fiscal year, who is reported with SUBJECT CODE of "196095".

With the exception of students in the Autism Scholarship program, all preschool students with a disability and between the age of 3-5 years by December 1 of the current fiscal year AND the reporting district has a district relationship (DIST_RELAT_CODE) value of "1" or "2" or ("3" with a value indicating the student is being sent to a BDD - FIRST_SENT_REASON_CODE or SECOND SENT REASON CODE = "MR").

All preschool students without a disability between the age of 3-5 years by December 1 of the current fiscal year; enrolled in a preschool program funded or administered by the Office of Early Learning and School Readiness (STDNT RECEIV CODE = "E")

OR

All preschool students without a disability between the age of 3-5 years by December 1 of the current fiscal year; reported with COURSE_SUBJCT_CODE="196095". For October (K) reporting:

• A potential student must have a Student Standing Record an EFFECTIVE START DATE less than or equal to November 14 of the current school year.



• A potential student must have a Student Standing Record with an EFFECTIVE END DATE on or after the start of the school year.

For Yearend (N) reporting:

- A potential student must have a Student Standing Record with an EFFECTIVE START DATE before or on May 1st of the current fiscal year.
- A potential student must have a Student Standing Record with an EFFECTIVE END DATE on or after March 23rd of the current school year.

Selection Criteria: Potential Districts

When multiple districts are involved in the student's education, the district having the lowest relationship (DIST_RELAT_CODE) value and who is also the legal district of residence (STDNT_RESDNG_DIST_IRN) will trump all other districts as the district responsible for reporting test records.

In cases, where none of the districts are the legal district of residence, then all districts sharing the lowest relationship value are responsible for reporting test records.

A district sending a student to a BDD, the sending district is responsible for reporting test records.

Logic

The program will check the student records for those students who should have PRESCHOOL ASSESSMENT records for the current reporting period of the current fiscal year, to determine which students do not have assessment records.

The program will check all districts reporting the student to determine which district is responsible for reporting the assessment records but none has been reported by the district.

Error Detection and Correction

- More than one open Student records (Student Standing and/or Student Attribute Effective Date record). Verify the report against the record containing the latest effective start date that is within the test window/
- The district with the lowest district relationship value has not yet reported the student. Look at the SSID report and see who else is reporting the student.
- The same information (state equivalent grade level and/ or, disability condition) is not being reported by all districts.
- Review the latest GEN_ISSUES report for errors related to the records described in the submitted data section.

The district should verify that admission date, effective dates, state equivalent grade level, and disability condition elements are reported correctly by the district.
