## Report Overview

### *General Description and Significance*

This report displays combined data from the Staff Demographic, Staff Employment, Contractor Staff Employment, Staff Course Master, Student Course, Student Gifted, and Student Program Records to present a comprehensive picture of gifted education staffing levels and services that are provided within a school district.

The report also provides a means for the district to review the reporting elements that directly impact the amount of funding received for a gifted unit.

Within a district’s report, there is one section of information for each included staff member. Coordinators and teachers are not treated differently in the report, as there are many staff members who serve in both roles (through multiple employment records). Contracted staff may appear on the reports for multiple districts.

- EMIS data elements are written in **SMALL CAPITAL LETTERS**.
- Report field names are written in **BOLD SMALL CAPITAL LETTERS**.
- Options (values) for each data element are indicated in *ITALICIZED CAPITAL LETTERS* and are enclosed in quotation marks.
- Record names are displayed in *italicized bold letters*.

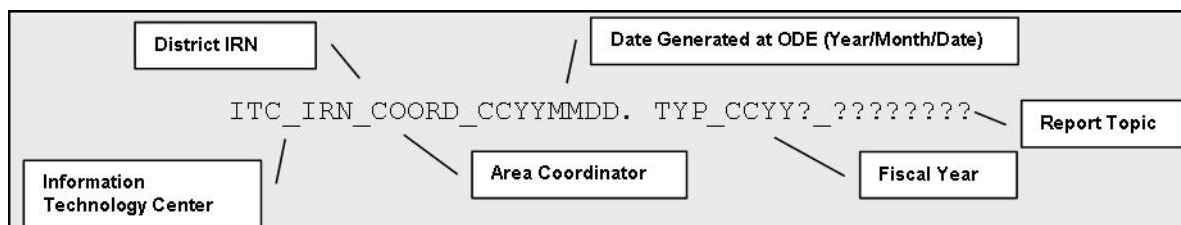

## **ODE Processing**

### ***Process Description***

Each week during the October (K) and Yearend (N) reporting periods, a report is created for any district with one or more staff members with a 999380 (Gifted and Talented) assignment area. Since gifted identification information is not reported in October, all students identified as **Gifted ID-???** will be counted for period K.

The data is extracted from Staff Demographics, Staff Employment, Contractor Staff Employment, Staff Course Master, Student Gifted, Student Course and Student Program Records as submitted by a school district.

### ***Data Source***

The data elements printed on the report come from the ***Staff Demographics, Staff Employment, Contractor Staff Employment, Course Master, Student Program, Student Gifted and Student Course Records*** as submitted by the districts. OEDS elements are used to identify the recipient of the report and to ensure that reports are sent to the appropriate districts.

### Report Selection Criteria

The 999380 assignment area (Gifted and Talented) is used to determine which staff to include in the report for a district.

The filter will be all Staff with ASSIGN\_AREA = 999380 and POSITN\_SEPRTN\_DATE >=1<sup>st</sup> day of Count Week .

All courses taught by the staff member, not just the gifted education courses are reported. When reporting staff employment information, all records are to be listed, not just records with the 999380 codes. This report will assist district staff in ensuring that gifted education staff are appropriately assigned and reported.

## Report Sample

### *Header Information*

The first area of the header describes information about the report generation. The upper left section names the program from which the report was generated and the data source. The middle information identifies the producer of the report and the report title. The upper right section states the date on which the report was generated, the page number and total pages, and the reporting period to which the report belongs.

The second area of the header pertains to the recipient of the report. It identifies the district for which the report was produced, its IRN and data submission dates of the district.

### *Detail Information*

For the number of students enrolled in each course, the count will have 4 parts, and vary for October (K) and Yearend (N). The report is organized as follows:

- Staff Demo data for a staff ID is listed
  - Staff Employment data for this staff ID in this district is listed (could be multiple rows)
  - Contractor Staff Employment data for this staff ID- where district IRN is contractor or contracting IRN is listed (could be multiple rows)
    - Note: The Contractor Staff Employment data detail line is only produced for contractor districts for other districts the line produced is: NO CONTRACTOR JOB RECORD FOUND
  - Course Master and student count data for this staff ID in this district is listed (could be multiple rows)
  - A count of students with 206XXX program codes reported with this staff ID across all school districts
- The next staff member is listed until all 999380 staff in district are listed
- A headcount for each of the 205XXX program codes reported by this district is listed

If no records exist for a section, “No Records Found” will be printed under the section heading.

Staff with a separation date before Count Week will not be included in the report.

Since gifted identification information is not reported in October, all students will be counted in as **Gifted ID-???** for the October (K) reporting period. At yearend, certification flags will be blank and headcounts will be reported appropriately.
