FUNCTION AND PURPOSE

These reports replace the STU_FED_CHILD Report. They are not the same reports, but they are similar. All traditional districts, community schools, and STEM schools receive the Federal Child Count Detail Report and the Federal Child Count Statement of Assurances Report as Level 2 reports in the Data Collector during the Beginning of Year Student (S) Collection and SOES Beginning of Year Student (S) Collection (referred to collectively throughout this report explanation as the Beginning of Year Student (S) Collections).

All students between the ages of 3 and 21 with a disability condition as of October 31 will appear on the Federal Child Count Detail Report and the Federal Child Count Statement of Assurances Report. The Statement of Assurances Report is a single page summary report that provides a total count of students by disability condition.

The Federal Child Count Reports can be used to verify the number of children with disabilities who are receiving special education and related services in accordance with an IEP on October 31 and may, therefore, be useful to special education directors and other district administrators as well as the district EMIS coordinator.

If this report explanation—in concert with the EMIS Manual—does not answer your questions or help you to resolve your issues with the Federal Child Count Reports, then the normal path to getting help with EMIS reporting should be followed. The first point of contact should be the EMIS coordinator, followed by the Information Technology Center, who will contact the EMIS helpdesk if necessary, and finally ODE EMIS directly.

DATA

The report name will indicate from which submission the data in the report was taken. Generally, the most recently reported data is used. The records used include the Student Demographic (GI), Student Standing (FS), Student Attributes—Effective Date (FD), Student Attributes — No Date (FN), and Student Special Education (GE) Records. From these records, the elements in *Table 1* are used.

DIST LRE SRC CODE DETERMINATION

Each row of data on the Federal Child Count Detail Report is assigned a Least Restrictive Environment (LRE) code using the following process.

IEP event records reported in the current fiscal year Beginning of Year Student (S) Collections and the prior fiscal year End of Year Student (S) Collections are checked to determine the most recent IEP that will be in effect on October 31.

- If a value exists, the value is reported in the FED CCT LRE CODE field
- The DIST LRE SRC CODE is "8" GE Record

The process determines if a value was reported for the Updated October 31 IEP Outcome (FN270) field. If the IEP is in effect as indicated above,

- If a value exists, the FED CCT LRE CODE value reported becomes the FN270 override
- The DIST LRE SRC CODE is "7" FN270 Override
- If a value exists, but the IEP is not in effect as of October 31, the record will be ignored

The process performs overrides for any value as referenced above based upon the reported How Received (FS180) Element.

- If the How Received value = "6 In-state Student Attending Nonpublic School" and the STDNT AGE NUMBER is over 5, the FED CCT LRE CODE value is IE39.
- The DIST LRE SRC CODE is "9" How Received = 6

If no values could be determined, then

- The FED CCT LRE CODE will be IENS (IEP Complete Not Served)
- The DIST LRE SRC CODE is "5" No IEP Reported

INCLUDE IN USDOE COUNT

Only certain students meet the criteria for inclusion in the counts sent to the US Department of Education. A student only needs to meet one of the following filters to be included. When students are reported in multiple districts, a check will be completed and business rules applied to either select the district where the student will count or to exclude the student from all districts when the business rules do not provide a single selection.

Students who are included in the USDOE count are flagged as "Y" in the FED CCT FLAG field on the report, and all other students are flagged as "N". Depending upon certain values reported for the FED CCT STATUS CODE or DIST LRE SRC CODE, the "Y" will be overridden and set to "N".

Districts should be aware that even though the FED CCT FLAG may appear as "Y" on the report, they cannot assume that the student will be included in the Federal Child Count. The "Y" indicates that the student meets the *initial* selection criterion to be included in the count. However, there may be other conditions that would exclude the student from the count and are based upon the element values reported or omitted by the district. The FED CCT STATUS CODE informs the district of the *status* of the student as it relates to the Federal Child Count, not that the student will appear in the count.

Traditional public school students will be included where

- How Received (FS180) = *, E, and
- Sent Reason 1 (FS200) or Sent Reason 2 (FS230) = (64, CI, FC, FP, JV, MR, NA, NI, NP, OE, OS, PS, SE, T1, AU, CT, ES, JP, CE, CO)
- Tuition Type (FS130) = N or A, and
- Legal District of Residence (FS150) <> 999999

Community school students will be included where

• How Received (FS180) = M

STEM school students will be included where

• How Received (FS180) = K

Head Start students, attending chartered non-public schools, or non-residents receiving special education services through your district or staff within it will be included where

• How Received (FS180) = 6

Students who are receiving services at OSD, OSB, DYS, Pilot Programs will be included where

- How Received (FS180) = U or Y, or
- Sent Reason 1 (FS200) or Sent Reason 2 (FS230) = PP

Students who are otherwise placed will be included where

- How Received (FS180) = C or P or T or Q or 2 or B or 9 or S or D or G or J, and
- Sent Reason 1 (FS200) or Sent Reason 2 (FS230) = (NA, CT, JV, ES, MR, OS, SE, FC, OE, 64, T1), and
- District IRN (FS040) = Legal District of Residence (FS150) or District IRN (FS040) is a Community School

TIE BREAKERS

When students are reported in multiple districts, a check will be completed and business rules applied to either select the district where the student will count or to exclude the student from all districts when the business rules do not provide a single selection.

There are four steps to determine in which district the student should be counted (if any) when more than one district meets the filters above.

- First tie breaker: If the student is reported by Buckeye United (060988), the student will be counted at Buckeye.
- Second tie breaker: The student counts in the district where the District IRN (FS040) = Legal District of Residence (FS150) or How Received (FS180) = M or K
- Third tie breaker: If the student has been reported by more than one district where the District IRN (FS040) = Legal District of Residence (FS150) or How Received (FS180) = M or K, the student will be counted in the district with the later Admission Date (FS070)
- Fourth tie breaker: If the student has been reported by more than one district where the District IRN (FS040) = Legal District of Residence (FS150) or How Received (FS180) = M or K and the Admission Date (FS070) from the districts are equal, then the student would not count for any district in the child count

ERROR DETECTION AND CORRECTION

This report is designed to provide districts with Federal Child Count related information that they and other districts have reported for their students. To assist districts in reviewing their information, the report provides information related to the Least Restrictive Environment (LRE) as calculated at ODE and the status of each student for the Federal Child Count. For each purpose, both a code and message are provided. The message for each student may indicate that action is required.

The DIST LRE SRC CODE and Description indicates the source of the LRE information derived for each student. Some codes indicate that an LRE was not derived since the student, as reported to ODE, should not be included in the child count. Other codes indicate the type of data source used to determine the LRE. There is no one "right" value for the DIST LRE SRC CODE and Description – they simply indicate how ODE is using the data on each student reported.

The FCC STATUS CODE and Description indicates the status of a student as it relates to inclusion in the child count sent to the US Department of Education.

Even when the messages indicate that the data is good, each district should review the information and make sure that it is accurate. This report only checks certain conditions. Therefore, inaccurate information could be reported, but not flagged.
