FY17 MARCH FOLLOW-UP (D) COLLECTION

March Follow-up Criteria



- ▶ Students to report
 - Prior year Concentrators **and**
 - Previous yearend dropout **or** graduate
- ▶ FY16 records
 - End of Year (S) Collection
 - CTE Program of Concentration (FN290)
 - Withdrawal Reason (FS100) 7x
 - Graduation (G) Collection
 - Diploma Date (FN090)
 - Diploma Type (FN100)

March Follow-up Process

- ▶ Districts gather survey results within 6 months after concentrators leave school
- ▶ ODE provides file of students meeting follow-up criteria
- ▶ Districts submit survey results in CTE Workforce Development Follow-up (GV) Record

FY17 March Follow-up (D) Collection

- ▶ Open February 13 through April 28
- ▶ Files added to Level 2 area of Data Collector

(CTFL-002) CTE March Follow-up Extract for FFE

- ▶ Download from Data Collector
- ▶ Change to .SEQ and import into Flat File Editor
- ▶ Update with survey results
- ▶ Export from FFE and upload to Data Sources/Other Files area in Data Collector
 - ▶ Automatically exports in .SEQ format
 - ▶ Can be changed to .TXT

Level 1 Missing Report

- ▶ Generated for students in original ODE file
 - ▶ Not included in upload
 - ▶ Excluded due to fatal Level 1 error
- ▶ Placeholder record added to Preview and Submission files
 - ▶ Default values for each element
- ▶ Other Follow-up Status (GV660)
 - ▶ X = Incorrectly reported as a CTE Concentrator

Records Reported

- ▶ CTE Workforce Development Follow-up (GV)
- ▶ Student Assessment (FA)
 - ▶ CTE Technical Assessment (GY)
 - ▶ CTE Industry Credential (GW)
 - ▶ CTE Industry Assessment (GU)
 - ▶ Phased out effective FY2016
 - ▶ Opportunity to clean up data for CTE Report Card

FY17 CTE March Concentrators Appeals

- ▶ New appeal process
- ▶ Only opportunity to add missing students
- ▶ Recommended research
 - FY16 CTE FTE reports
 - FY16 CTE Program of Concentration (FN290) reporting
 - FY16 CTE Matrix
 - Verify subject code aligned with program of concentration

Not Appealable

- ▶ Not reported as having left school in FY16
- ▶ Reported as withdrawn using withdrawal reason 99, but no diploma date
- ▶ Reported as still enrolled in FY17

CTFL-003 Approved Appeals Report

- ▶ Additional students based on approved appeal
- ▶ CCP CTE students incorrectly omitted from original 17D file
 - ▶ 265 total statewide
 - ▶ Affected districts will receive notification of report availability for added students

GENERAL UPDATES

Federal Child Count

- ▶ Snapshot date is Monday, March 6, 2017
 - ▶ Traditional districts make needed updates in 2TRD
 - ▶ Community schools and STEM districts make needed updates in BODE
 - ▶ Reminder – GE Records are not appealable
- ▶ Level 2 reports added to Data Collector
 - ▶ FCCD-001 Federal Child Count Detail
 - ▶ FCCS-001 Federal Child Count Statement of Assurance

Preschool

A new site location IRN was issued to some ODE licensed preschools

- ▶ When the new OCLQS system went live
- ▶ All impacted entities were notified via letter from Early Learning
- ▶ This new IRN is **not** EMIS reportable
- ▶ Continue to use original IRN for EMIS

FTE Detail and Adjustment Reports

- ▶ Severity column added
- ▶ Report explanation updated as of February 15, 2017
- ▶ Reports updated daily
 - Most recently reported data used
 - Can change due to cross-district data

Changes Moved to FY18

- ▶ 39128 – Update reporting instructions on Court-Placed Students
 - ▶ Facility defined by ORC §2151.65 or §2152.41
 - ▶ Reporting district is educating
- ▶ 39626 – Placeholder for EMIS changes needed for NCLB to ESSA transition period
 - ▶ Begin gathering data for three new subgroups in FY17
 - ▶ Military
 - ▶ Court/foster
 - ▶ Homeless

Changes Moved to FY18, cont.

- ▶ 41429 – Remove requirement for Special Ed assignment area where no longer needed
 - ▶ Old codes can still be used for FY17
 - ▶ Will be deleted for FY18
- ▶ 41898 – Determine which data elements on FD record can be reported with default values when student is District Relationship of ‘3’
- ▶ 43637 – Add new position codes (CK060)
 - ▶ School Resource Officer
 - ▶ Reading Intervention Specialist

EMIS Data Appeals

- ▶ Redesigned web page
 - ODE Home > Data > EMIS > EMIS Reporting Responsibilities > EMIS Data Appeals
- ▶ Tentative FY17 schedule posted
 - KG Readiness Assessment March 6 – 15
 - CTE March (D) Follow-up May 8 – 19

EOC Score Not Reported

- ▶ **W** – Credit received due to course completion prior to EOC assessment availability
 - ▶ Report number of grad points earned for Score
- ▶ **X** – Credit received due to completion of dual credit course
 - ▶ Report number of grad points earned for Score
- ▶ **Y** – Student transferred in with course already completed
 - ▶ Report Score = blank

OHIO DISTRICT DATA EXCHANGE (ODDEX)

ODDEX

- ▶ Reminder – primary application for smaller applications
- ▶ Reminder – each application is populated by submitting to appropriate collection request
- ▶ Hide/show feature coming to Landing Page
 - ▶ Helpful for users with access to multiple areas

Student Cross Reference (SCR)

- ▶ SCR and other Student Collections should be performed at the same time
 - ▶ Two independent collections
- ▶ SCR conflicts do **not** affect funding
 - ▶ EPCT is only exception
 - ▶ All others can be ignored once verified
- ▶ Data updated nightly based on most recent submission
- ▶ Time stamp added to Audit History

STIC/RFIC Checks

- ▶ STIC/RFIC known issues discussed in January ongoing
- ▶ Error corrected with latest release
 - ▶ Problem with RFIC and STIC checks causing conflicts to be generated in error
 - ▶ Impacted students withdrawn prior to start of school year

SCR Future Enhancement

- ▶ Ability to mark conflicts as 'Reviewed'
 - ▶ Hide from grid display
 - ▶ Indicator shows there are hidden conflicts
 - ▶ Conflict again visible if data updated and conflict remains
- ▶ Add additional selection
 - ▶ By Conflict code

SOES Update Process

- ▶ SOES Student data updated nightly based on most recent EMIS submission
- ▶ SOES Contact data
 - ▶ Forwarded to SSDT
 - ▶ Merged with Student data
 - ▶ Refreshed nightly
- ▶ Derived enrollment date
 - ▶ Latest of the FS effective date, FS admission date, or DL first day of school

SOES Changes

- ▶ Contact data update process modified
 - ▶ District submits new contact data
 - ▶ Student with a single Derived Enrollment record
 - ▶ Student moves within same resident district
 - ▶ Most recently submitted contact data applied
- ▶ Time stamp added to Audit History

College Credit Plus (CCP)

- ▶ Updated manually
- ▶ Data load status
 - ▶ FY16 – not complete
 - ▶ FY17 – ongoing
- ▶ Agreements now has export capability
- ▶ Updated data from the college will cause 45 day review period to reset

Additional Enhancements

- ▶ Adding Special Ed History
- ▶ Adding Assessment History
