  - ▶ FCCS-001 Federal Child Count Statement of Assurances
- ▶ Uses data from Beginning of Year Student (S) collections
- ▶ Used to verify all students with disabilities who have valid IEPs in effect as of October 31
  - ▶ Identified and served

- ▶ Date of Birth (GI070)
  - ▶ Age between 3 – 21 as of October 31
- ▶ Student Standing (FS) Record
  - ▶ Where October 31 is between Effective Start Date (FS060) and Effective End Date (FS090)

- ▶ Federal Child Count (Fed CCT) Status Code and Description
  - ▶ Status of student as related to Fed CCT
  - ▶ Used in determining Severity Code assignment
- ▶ Fed CCT Least Restrictive Environment (LRE) Code
  - ▶ If blank, student not included in count

# Proper Certification

- ▶ Used to determine if teacher is properly certified or licensed to teach course
- ▶ Compares teacher credential to
  - ▶ Subject Code (CN050)
  - ▶ Student Population (CN340)
  - ▶ Grade level of students in course
- ▶ Comparison outcome then assigns
  - ▶ Result Code
  - ▶ Proper Certification Flag Y/N
  - ▶ Severity Code

# Which Teacher Is On Report?

- ▶ Only one teacher reported for course?
  - ▶ That teacher appears
- ▶ Multiple teachers reported for course?
  - ▶ Teacher with greater percentage of time with the course
  - ▶ If equal percentages, then whichever is properly certified
  - ▶ If all or none properly certified, then first one comes to

# Troubleshooting

## What to look for

- ▶ Is license valid for subject code?
- ▶ Is license valid for grade level?
- ▶ Is license valid for population?
- ▶ Are there students in the course?
- ▶ Does the Teacher State ID start with a Z?
- ▶ Does the teacher have only a substitute license? Is this a traditional public school?
- ▶ Is the credential currently valid?

# What's New?

- ▶ **Preschool Poverty Level (FD120)**
  - J = Income info not obtained, child in protective custody
- ▶ **Military Student Identifier (FN430)**
  - C = Reserve Duty
- ▶ **72-Hour Rule, effective November 2, 2018**
  - Withdrawal Reason (FS100) = 76

# Attendance: Sending District Reports

- ▶ School-age students educated by ESC staff
  - Report just like attending students
- ▶ Board of DD students
  - Sent Reason (FS200, FS230) = MR
- ▶ Non-public students at district expense
  - Sent Reason = NP
- ▶ Proprietary Institution students
  - Sent Reason = PI
- ▶ College Credit Plus students
  - Sent Reason = PS
- ▶ Student Standing (FS) Record

# Attendance: Truancy and Excessive Absences

- ▶ Report events as they occur
  - All records in place from beginning of year?
- ▶ Triggers determined based on absences at all educating entities that report attendance in EMIS
- ▶ Concurrent enrollment, both entities report
  - Example: JVS satellite student
- ▶ Resource: “Ohio’s Attendance Laws FAQ”
  - Chronic Absenteeism webpage
- ▶ Student Truancy and Excessive Absence (FT) Record

# Accelerated Students

- ▶ Must have a *Written Acceleration Plan (WAP)* to be considered accelerated
  - Including “early entrance”
- ▶ Acceleration does not follow student
- ▶ WAPs are district specific
  - New district must write new WAP
- ▶ Accelerated students are not always gifted
- ▶ Gifted student are not always accelerated
- ▶ Student Acceleration (FB) Record

# Gifted Students

- ▶ Must have a Written *Education* Plan (WEP) if gifted services/education provided
- ▶ Identification follows student
  - Once identified, always identified
- ▶ WEPs are district specific
  - New district must write new WEP
- ▶ Student Gifted Education (GG) Record

# Discipline

- ▶ Only reported if Total Discipline Days (GD090) greater than .00
- ▶ District where discipline administered reports
- ▶ Incident occurs in Building A, student ends year in Building B
  - ▶ Building IRN (GD040) = B
  - ▶ Building IRN where Discipline Incident Took Place (GD120) = A
- ▶ **New** Victim of student violent behavior
  - ▶ Student, teacher, non-teaching staff
- ▶ Student Discipline (GD) Record

- ▶ FTE and CTE FTE versions work the same way
- ▶ Grouped to generally match School Finance Payment Report (SFPR) and accompanying worksheets
- ▶ Review regularly


