

# FY20 Graduation

### **Course Requirements**

Report all credits earned through September 30 on Student Graduation-Core Summary (GC) Record

Courses	State Minimum
English Language Arts	4 credits
Health	½ credit
Mathematics	4 credits
Physical education	½ credit
Science	3 credits
Social studies	3 credits
Electives	5 credits

# **Graduation Pathways**

- Verify all reporting is in place for students meeting a pathway, even if graduating via HB 197 flexibility
- Assessments
  - –Pathway 1: End of Course
  - -Pathway 2: Industry Credential/WorkKeys
  - –Pathway 3: ACT/SAT
- Program codes
  - –Alternative pathway option 1: Non-CTE focus
  - -Alternative pathway option 2: CTE focus

# **Diploma Date**

- Must be prior to the earliest first day of school being reported on FY21 calendar to count in the FY20 graduation rate
- Both of the following should be true for the date reported
  - -Graduation requirements were completed and
  - -Student has left formal secondary education

#### **Graduation Seals**

- Seal of Biliteracy program codes
- Ohio Means Jobs Readiness Seal program code
- All other program codes uploaded to the Data Collector will appear on Excluded list

# **Assessment Exemptions**

- Should not be removed for students on a regular pathway who would have been exempt if testing took place
  - Report Student Special Education Graduation
     Requirement (FE) Record
- Exemptions can be removed for students on an alternative pathway
- New "Data Reporting for Students with Disabilities FAQ" on COVID-19 webpage

# FY21 Retention – Grade 3 Only

#### **HB 197 Clarification**

- Flexibility not to be used as a means to report all grade 3 students with Retained Status option of "\*"
- Districts can make determination to retain students not reading at grade level and academically not ready for 4th grade

# **Reporting Clarification**

- Report all Grade 3 students
- All Retained Status options are still valid
- TGRG alternative assessment promotion score met?
  - Options J N identifying assessment
- Exempt from retention under TGRG law?
  - Options D F identifying exemption
- Significantly cognitively disabled?
  - Option G signifying overall TGRG exemption

EMIS Data Review and Verification is the process by which all districts and community schools certify they have reviewed the data reported by the district in EMIS and verify that their data is accurate and complete to the best of their knowledge.

# FY21 Initial Calendar

# Minimum Requirements

- At least one district-level set of calendar records
  - -First Day of School (DL080)
  - –Last Day of School (DL090)
  - -Hours Per Day (DL100)
  - -C\_DPLANNED (DN090)
- Optional to submit complete district-wide calendar details

# **Benefits of Reporting Detail**

- More accurate FTE calculation
- Fewer state default calendar assignments
  - Appears as 999999-\*\*-\*\* on FTE Report
  - Occurs when no match can be made with
    - District or building IRN
    - State Equivalent Grade Level
    - Attendance Pattern
- ODDEX
  - -Calendar popups
  - -SOES Student Derived Enrollment Date

# FY21 Beginning of Year Student

#### Reset and Restart Education

- Planning for Blended or Remote Learning
  - Provides comparison of both as potential options for reopening
- Attendance Considerations for Remote Learning includes information for
  - Gauging attendance in remote learning situations
  - Tracking attendance
  - Local attendance and absenteeism policies

# FY21 EMIS Changes, 1

- Fatal error when students reported with How Received X reported with disability condition (21-38)
- "IN" no longer valid grade level option (21-40)
- Resume collection of GC record for nongrads (21-44)
- Clarify PSTC reporting requirement for DOR (21-52)

# FY21 EMIS Changes, 2

- Temporary change for "DD" disability condition to be reported for kindergarten students until December 1, 2020 (21-54)
- "DD" disability condition for Preschool students 6 years or older only valid through December 1 (21-55)
  - As of December 2, school age disability condition must be reported
- Manual clarification that ESCs should be reporting preschool discipline data (21-28)

# Student Cross Reference (SCR) Collection

- Submit up-to-date data frequently to ensure 30day funding rule is adhered to
  - Report continuing students within 30 days of start of school
  - -Report changes within 30 days of change
- Submit other student collections at the same time to keep records in sync and History up-to-date
  - SOES Beginning of Year (S) already open for community schools and STEMs
  - Beginning of Year (S) for traditional districts opens early September

# **SCR Display Modes**

- Conflict
  - EPCT is the only conflict that indicates a funding issue may exist
    - Refer to FTE Adjustment Report
    - Make sure Student and SCR data submissions match
- Not Reported/Mismatched
  - Your reporting does not correspond with another district's
    - Admitted From/Withdrawn To
    - How Received/Sent To

# **SOES Auto Approval, 1**

- Resident district prevented from flagging when
  - Current year record identical to previous year record, and
  - Final disposition of previous year record was reviewed/approved



- Occurs when critical elements unchanged
  - -Parent/Guardian
  - -Address
  - -District of residence

# **SOES Auto Approval, 2**

- Resident district has proof student moved but community school has not updated address
  - Resident district post comment to request address update
- Resident district will have ability to escalate
   14 days after commenting
  - -Look for green up arrow
- Area coordinator has discretion to override when appropriate

# FY21 Initial Staff and Course

#### **Review Staff Data**

- "509" no longer a valid Position Code option (21-24)
- Report Position Status "U" for staff who left at end of last year but not reported as separated in FY20
- Do not include staff reported as separated last year in FY21

#### **Review Course Data**

- Review courses for deleted subject codes (21-4, 21-5)
  - **-178015**, **178025**, **990371**
- Review curriculum code for courses with 177000 and 177011 subject codes (21-7)
  - -"VM" now valid option



- Substitutes (21-21)
- Licensure flexibility for FY21 school year
  - Expiration dates extended
  - -Temporary licenses




