
Appendix K - Summer School

FY 05 SUMMER SCHOOL REPORTING INSTRUCTIONS

This special appendix to the EMIS Guide is a tool to assist EMIS users in reporting summer school data for summer school that occurs after the regular school year, during the period from June-August 2004. Only program codes and elements on the **District General Information – Previous Summer** and **Building General Information Record – Previous Summer** Records will be reported to account for summer school activities. Only the resident district should report the summer school data. If a student attends summer school classes in another district or entity, the resident district should request the information from the provider and report the summer school data for that student. This appendix refers ONLY to the data elements used to report summer school information.

Summer Testing

Summer ninth grade proficiency test results for students who still need to pass one or more of the “subject” tests in order to graduate (members of the classes of 2004, 2005 and 2006) should be reported on the Ohio Proficiency Tests Record during the FY05 Yearend N reporting period. This includes:

- **students who passed the necessary “subject” tests during the summer of 2004, were issued diplomas dated *prior to the beginning of the FY05 school year, and***
- **students who completed course requirements and are no longer enrolled in the district.,**

The results of the **3rd grade reading achievement test** and the **4th grade reading proficiency test** taken during the summer of 2004 should NOT be reported to EMIS.

Summer Graduation Information

Students who are enrolled in the district that graduate during the summer after the end of the 2003-2004 school year, and were **issued diplomas dated *prior to the beginning of the FY05 school year,*** should be reported during the FY05 October K reporting period with the diploma type and the date that the diploma was issued.

Student Course Information

Courses taken during this summer **will not** be reported to EMIS, including courses taken for credit and/or to complete graduation requirements. These instructions may change for the FY06 summer school reporting.

STUDENT - ATTENDANCE (section 2.1.2)

Retained Status (refer to section 2.1.2.17):

This data element is only reported in the October (K) reporting period.

This element indicates whether a student who was retained at the end of the school year will advance to the next grade level as a result of the summer school experience. If a student attends summer school either at or outside his/her resident district and is promoted after the successful completion of summer school, the district of residence should report the data in the October K reporting period.

When calculating statistics for students participating in summer school programs:

- If retained status for October = “* - Not previously retained” OR “1 - Previously retained at end of school year, and still retained”, then the student will be counted in the current student grade level (reported on the student demographic record in October).
- If retained status for October = “2 - Previously retained at end of school year, but advanced because of successful completion of summer school”, then ODE will subtract one from the total number of retentions for the grade level in which the student was enrolled in June).

2.1.8(K) STUDENT PROGRAM RECORD

The elements listed below will be reported for each program in which a student participates. The number of programs in which a student can participate is unlimited. If the student was in the program and then withdraws from summer school, the program code should still be reported by the resident district.

2.1.8.1(K) Program Code

Indicates the program (from the student program codes in Appendix E) in which the student is receiving service. If the programs listed do not exactly match the service being provided, select one which best describes the program.

Summer School Program Codes Reported in October

The following program codes are reported on the student program record during the October K reporting period to indicate that the student participated in a particular program during summer school (June - August, 2004). Districts should report all codes that apply.

Student Intervention Program Codes (Intervention funded with Student Intervention Grant Funds (GRF 200-513))

Student Intervention Codes 151260 through 151430 should be used to report intervention provided during the SUMMER that has been funded with Student Intervention Funds (GRF 200-513). Students eligible for intervention funded with Student Intervention Funds are those students who were enrolled during the 2003-2004 school year in grades 1, 2, 3, and 4 in all districts or grade 9 in districts that were designated in Academic Emergency status on the 2001-2002 and/or 2002-2003 Local Report Cards. Districts can use these funds for salaries, materials and training to provide SUMMER intervention and will report the participation of students through EMIS during the FY05 October K reporting period.

Students in Grades 1-4 (Intervention supported with Student Intervention Funds)

Students who were enrolled in Grades 1-4 during the 2003-2004 school year are eligible for student intervention services funded with Student Intervention Funds (GRF 200-513) during the SUMMER if they meet the following criteria:

- Performed "below proficient" on the Ohio 3rd grade Reading Achievement Test, the Ohio 4th grade Reading Proficiency Test or on a reading diagnostic assessment administered by the district.

Intervention must be provided in **reading only** and **must include intensive phonics instruction**.

Students in Grades 9 (Intervention funded with Student Intervention Funds)

Students who were enrolled in grade 9 **during the 2003-2004 school year** are eligible for student intervention services funded by Student Intervention Funds (GRF 200-513) that were provided during the SUMMER of 2004 if they meet the following criteria:

- Student must have been a ninth grade student during the 2003-2004 school year and enrolled in a district identified in ACADEMIC EMERGENCY STATUS DURING THE 2001-2002 AND/OR THE 2002-2003 SCHOOL YEAR.
- Student performed “below proficient” in *any* subject area on either the 9th grade Ohio Proficiency Tests OR the practice tests for the Ohio Graduation Test.

Intervention can be provided in ANY SUBJECT AREA – READING, WRITING, MATHEMATICS, SOCIAL STUDIES/CITIZENSHIP, and SCIENCE – in which student performed “below proficient”.

Although only certain students at particular grade levels are eligible to receive intervention provided with Student Intervention Funds (GRF 200-513) during summer, the requirement for districts to provide intervention to all students who meet the criteria identified in House Bill 3 remains in place.

Additional students required to receive intervention required by HB 3 include the following:

- students who score below the proficient level on the state proficiency tests,
- students who score below the basic level on state achievement tests and
- students who do not demonstrate academic performance at their grade level based on the results of a diagnostic assessment.

The data collected through these program codes will NOT be used for funding purposes but will be used for statistical purposes, legislative requests and to support budget requests.

This record should be reported in the October K reporting period by every district that offers summer school activities. Districts/buildings that do not offer summer school activities are **NOT** required to report this record to EMIS.

4.1.1.11(K) Number of Extended Learning Time Instruction Program "Sites" Not Owned by the District

The definition for Extended Learning Time Instruction is "Any method of program-sponsored (including schoolwide program) service instructional delivery that extends the total hours of a school day, week, or regular approach term beyond that which would otherwise be available for learning. This category would include early-morning and after-school programs; evening programs and other programs that extend the time for learning outside of the traditional "9:00-3:00" school day; programs that alter the school schedule to accommodate migratory student schedules; Saturday programs; extended-time kindergarten, and summer school, methods that substitute one type of learning time for another within the traditional school day, such as pull-out or in-class tutoring, are not considered extended-time instructional approaches .

For the following two items, a "site" refers to any location that a Extended Learning Time Instruction program is held, other than a building within the district.

For example: a site can be a YMCA, or Parks and Recreation site. Because buildings can indicate on the Building record whether or not an Extended Learning Time Instruction Program is housed within their building, in this element do **not** include buildings owned by the school district. Only include sites housed at locations that are NOT district buildings.

These data elements are reported in the October K reporting period for activities occurring during the summer and in Yearend N reporting period

4.1.1.11.1(K) Extended Learning Time Instruction Program - Number of Sites (Title I) Not Owned by the District

Report the number of sites in this district other than buildings owned by the district that have Extended Learning Time Instruction Programs AND are funded by federal Title I (Part A) funds.

Default = "000"

4.1.1.11.2(K) Extended Time Learning Time Instruction Program-Number of Sites (21st Century) Not Owned by the District

Report the number of sites in this district, other than buildings owned by the district, that have Extended Learning Time Instruction Programs AND are funded by federal 21st Century Community Learning Center Program funds.

Default = "000"

4.1.2(K) BUILDING GENERAL INFORMATION RECORD – PREVIOUS SUMMER

This building record should be reported in the October K reporting period by every building with a valid IRN that offers summer school activities. Buildings/districts that do not offer summer school activities are **NOT** required to report this record to EMIS.

Report the six-digit number that identifies the school building.

4.1.2.2(K) District IRN

Report the six-digit number that identifies the school district.
