Source file is the FA record type labeled with the A data set. Data must be uploaded in EMIS manual format through the Data Collector Data Sources tab. All FA assessment types can be included in upload file, but only the following assessments will be reported to ODE and appear in the Student Assessment Records (FA) preview: Industry Credential (GW), International Baccalaureate (IB), Scholastic Aptitude Test (SA), American College Testing (AC), Advanced Placement (AP) and ACT WorkKeys (WK).
