New or updated reports: A new reported named, Counts of DN Records Excluded Report now available, which provides the counts per Attribute Group (i.e PE Evaluation, Student, Calendar, CCP, etc) by type of issue causing the exclusion;

- Incorrect District IRN (DN040),
 - District IRN (positions 17-22) does not match the submitter IRN in the Data Collector
- Incorrect Attribute for Org Type (DNORGTYPE), or
 - Attribute is not to be reported by the reporting organization type
- Incorrect Collection Window (WRNGCW)
 - o Attribute not collected in the current collection, it is to be reported in a later window

The value in parenthesis above is now displayed on the Excluded Records report to help identify the cause for the DN record being excluded. Likewise, the attribute group name is added to the end of the description field, to further help identify the record.

Finally, a new report named: Missing Report - Organization Attribute (DN), is now included to highlight the Attribute Names that are required to be reported by Org Type and Collection Request but were either not included in the submission or were marked as invalid.
