

# **EMIS Release Notes – New Collection Request**

Collection Request Name: Staff and Course Collection – Initial (FY23)

**Collection Request Description:** This collection is required for all EMIS reporting entities. The initial collection includes staff employed any time in FY23 and staff who were employed as of the end of the FY22 school year who are no longer employed as of the beginning of this school year. It also includes Course Master, Student Course, and related data for the entire school year. The source files are the CC, CI, CJ, CK, CL, CM, CN, CP, CU, CV, and GN Record types labeled with the L data set. Data must be uploaded in EMIS Manual format through the Data Collector Data Sources tab. Some staff data may be collected via SIF in those districts using USPS.

- Added the following validation checks (see Change 23-29). Note that the State Staff ID reported on the CI Record is populated by the Department onto the CK, CJ, and CL Records.
  - CK.0036—if the State Staff ID on the CI Record is reported as all 0s or is not formatted as 2 upper case letters followed by 7 numbers.
  - CJ.1005—if the State Staff ID on the CI Record is reported as all 0s or is not formatted as 2 upper case letters followed by 7 numbers.
  - CL.0011—if the State Staff ID on the CI Record is reported as all 0s or is not formatted as 2 upper case letters followed by 7 numbers.
