- In cases where a member or group of members has a specific complaint about forum use, that complaint should be sent directly to the group administrator for action by clicking "Contact Group Owner" at the bottom of the email or in the app itself by clicking "Report this message" under the MORE menu option.
- Forum members are expected to prevent any automatic replies such as out-of-office messages and read receipts from being sent to the group. Not doing so will result in the suspension of posting permissions.
- Commercial or vendor direct solicitation postings are prohibited and will result in the group member being banned from the forum.
- Resources shared should be properly cited and in adherence to copyright regulations.
- Community messages are not actively deleted or archived, and will be kept in accordance with Groups.io retention policies.
