

## State Foundation Payment Letter

### Fiscal Year 2024 November JVSD Payment on November 15, 2023

#### General Information on State Foundation Payments

Foundation payments to Joint Vocational School Districts (JVSD) are calculated once a month. This letter, generated with each foundation payment, provides details about updated payments to these entities including fund deductions, adjustments and transfers. The scheduled payment dates for FY 2024 are below:

July 14, 2023	January 12, 2024
August 15, 2023	February 15, 2024
September 15, 2023	March 15, 2024
October 13, 2023	April 15, 2024
November 15, 2023	May 15, 2024
December 15, 2023	June 14, 2024

The recently enacted state budget (Amended Substitute House Bill 33 of the 135<sup>th</sup> General Assembly) included several changes to the calculation of state foundation funding. The provisions of the budget have been fully implemented.

#### Information Relevant to the November Payment

- ADM data used in the calculation of Base Cost Enrolled ADM are based on FY2023, FY2022 and FY2021 data.
- **FY 2024** ADM and categorical data for special education, English Learners, economically disadvantaged students are based on compilations as of 11/02/2023.
- **FY2023** Final # 2 adjustments were included in the November payment. Adjustments were made using JV04. Adjustment amounts can be viewed at the following [link](#).
- FY2023 Final # 1 deductions that were spread over this fiscal year will continue to impact settlement reports. JV03 code was used for FY2023 Final # 1.
- Feminine hygiene dispenser payments were included in the November payment. Payments were made using JV20.

#### Statement of Settlement

The Statement of Settlement shows the amount of funding by component paid monthly from SFPR and non-SFPR sources. Typically, the monthly amounts fluctuate based on data updates that occur during each payment period. On the statement of settlement, funds are generally paid out on a [percentage basis or the remaining payments of the year basis](#).

The adjustments below are applied to the FY 2024 November payment. These items are reflected on the statement of settlement with their respective journal voucher codes for proper accounting. This payment includes:
