# Spring 2017

# **LEARNING**

#### District leaders and teachers

Learn about the revised standards, as well as the supporting documents and videos for your grade level or levels.

#### **PLANNING**

#### District leaders

Develop transition plan for updating local curricula. Update will address knowledge and skills found in the revised standards, as well as complexity of thought expected. Review the *Using the Standards for Curriculum* section on the model curriculum webpage for resources.

Begin updating local curricula based on the standards revisions.

#### **Teachers**

Determine transition plan for updating grade-level instructional plans to address knowledge and skills found in the revised standards, as well as the complexity of thought expected. Review the *Using the Standards for Curriculum* section on the model curriculum webpage for resources.

Experiment with resources, strategies, or classroom examples that address the revisions.

Develop expertise in new grade-level content. Utilize best practice instructional strategies present in the model curriculum.

Begin grade-level transition plans. Efforts lead toward fully implementing local curricula, which are based on revisions to the 2017 Ohio's Learning Standards and 2017 model curricula.

Continue to experiment with the resources, strategies, or classroom examples that address the revisions.

Plan professional development for staff about the 2017 Ohio's Learning Standards, 2017 Model Curricula, and assessment.

#### **Teachers**

Begin participating in related professional development supporting deeper content knowledge, increased rigor, and instructional practices.

Evaluate lessons to ensure curricular focus. Eliminate parts of lessons or units that do not have a strong connection.
