State Board of Education - May Update

## STATE BOARD OF EDUCATION

Interim Superintendent - At the May State Board of Education meeting, the Board selected Dr. Chris Woolard to serve as the Ohio Department of Education's (ODE) interim superintendent of public instruction beginning May 28. Outgoing Interim Superintendent Dr. Siddens said, "I have worked with Chris throughout my 17 years with ODE and am confident he will do an amazing job in the role given his 19 years of service to the department!"

**Superintendent Search** - The State Board passed a resolution to hire Rea & Associates to assist with the superintendent search, which was previously delayed as the Ohio House and Senate consider legislation (S.B. 1 and H.B. 12) that would significantly impact the role and its responsibilities.

Constitutionality Resolution - The board also took action at its May meeting to seek a formal opinion from the Ohio attorney general (or designated independent counsel) on whether S.B. 1 and H.B. 12 conform with the intent of Ohio's Constitution. The resolution passed by the board begins with an affirmation of its constitutional charge to provide general supervision of the system of public education in Ohio and its uncertainty of the constitutionality of legislative proposals that would limit its role.

# Governor supports "science of reading" approach

As previously reported, Governor Mike DeWine issued a literacy executive order against the backdrop of concerns regarding reading proficiency scores among elementary school students. He supports a science of reading-based approach to improve literacy in the Buckeye State.

The governor has observed reading lessons in a series of school visits and encouraged legislators – who continue deliberations on the state biennial budget bill which originally proposed \$168 million in literacy funding – to do so.

Against push-back from stakeholders who oppose mandated approaches to teaching, Governor DeWine remains firm in his belief that the science of reading-based approach is best for students.

"The jury's back, the verdict is in, and we need to pay attention to that," he said.

"My conviction that this is vitally important to Ohio and Ohio's future, vitally important to our children's future, has certainly been reinforced as I've traveled around the state," he continued.

The governor is talking with leaders in Ohio's higher education community about the need for teacher programs to promote the science of reading approach.

"This is where we need to go," he said. "Schools of education need to switch over."

### **Budget bill deliberations continue**



Every state biennial budget is unique, but one characteristic remains constant: change throughout the legislative process.

Among the issues debated in the House is how best to continue implementation of the Cupp-Patterson school funding plan put in place through the budget bill passed by the legislature two years ago. Some advocate for full phase-in of the funding strategy in the next two (rather than four) years as originally planned, while others support maintaining the phase-in schedule and using cost data from 2022 (rather than from 2018) as called for in Governor Mike DeWine's budget proposal.

The Ohio 8 Coalition, comprised of union and administration leaders from the large urban districts (Akron, Canton, Cincinnati, Cleveland, Columbus, Dayton, Toledo and Youngstown) is among those advocating for updating the cost data. The coalition also opposes expansion of the EdChoice private school voucher program, saying it "does not make good financial, academic, or accountability sense."

Governor Mike DeWine's proposal to fund school resource officers (SRO) for every building (up to \$94,500) through an allocation of \$194 million per year (which as eliminated by the House) has also been subject to debate.

A coalition – comprised of the American Civil Liberties Union of Ohio, Children's Defense Fund-Ohio, Juvenile Justice Coalition, Ohio Poverty Law Center and Policy Matters Ohio – recommended that there be greater flexibility on use of the funds (for counselors and mental health professionals) and additional training requirements for SROs if the funds remain in the budget bill (H.B. 33).

Governor DeWine seemed unreceptive to the recommendations, pointing out that Student Wellness and Success Funds are provided to support students' mental health-related needs. He also noted that the last two state biennial budget bills included \$1.3 billion in wellness funding to support students' various non-educational needs.

Changes made in the House of interest to K-12 stakeholders include:

- Elimination of the requirement that students who fail to demonstrate proficiency on the third-grade English language arts assessment be automatically retained;
- Literacy -- an increase to governor's early childhood education funding and cuts to educator professional development and high-quality instructional materials;
- A line-item increase in charter school facilities funding;
- A requirement that schools provide a transfer student's school records to the new school within five days of receiving the request;
- Establishment of a transportation pilot for up to five ESCs to transport students in a partnering district to charter and private schools; and,
- Elimination of a requirement that students complete FAFSA as a graduation requirement.

# Trans sports ban opponents supporting existing rules

Controversy continues over legislation (H.B. 6) to prohibit transgender girls from participating on sports teams consistent with their gender identities.

Supporters say the legislation is needed to ensure fairness, citing differences in the physical abilities of males and females which serves as the rationale for creating separate sports teams for boys and girls, and men and women. Opponents say the bill targets a problem that doesn't exist in Ohio, with some in support of the Ohio High School Athletic Association's existing policy that requires transgender girls to receive at least one year of hormone treatments and provide medical evidence that they do not have physical abilities superior to students they would complete against.

Witnesses testified on the emotionally charged bill during legislative hearings held in the House.

# High school financial literacy licensure validation

The State Board of Education approved a draft of OAC 3301-24-30 Educator License Validation in Financial Literacy Instruction in April. The Ohio Department of Education (ODE) must now file the administrative rule with the Joint Committee on Agency Rule Review (JCARR). ODE is currently developing a financial literacy Ohio Assessment for Educators, as required by the rule, and will begin accepting applications for this new validation upon State Board approval.
