Ohio FY 2024-2025 budget approved

Late in the evening of July 3rd, Governor Mark DeWine signed the Fiscal Year 2024-2025 budget. The new bill focused on school choice



including and comes with some significant changes for education across the state, including a reorganization of the State Department of Education and increases in education funding.

The overall increase in school funding is particularly beneficial for charter schools. Historically, Ohio charter schools have only received 70%-75% of the funding that their district counterparts received. Under the new budget, high-performing charters, according to key report card metrics, will receive an additional \$3,000 per economically disadvantaged student and \$2,250 per non-disadvantaged student. Facilities funding for brick-and-mortar charter schools will double from \$500 per student to \$1,000 per student. A new equity supplement will provide all brick-andmortar charters with an additional \$650 per pupil in funding. Combined, these measures narrow the funding gap between charter and district schools, with all brick-and-mortar charters receiving 86% of the funding of their district counterparts and highperforming charters receiving as much as 92% of the funding of their district counterparts.

The approved version of the budget resulted in \$3 billion in tax cuts which falls between what the House and the Senate had proposed. The tax cuts do not translate into decreased education spending; included in the approved bill is the more generous version of the Cupp-Patterson funding formula, bringing an estimated \$550 million back to public schools.

In another compromise between what the House and the Senate proposed, the minimum teacher's salary is being increased to \$35,000 as part of the bill. The Senate had proposed a minimum salary of \$30,000 and the House a minimum salary of \$40,000.

With a focus on increasing educational options to families, the budget includes a plan to expand universal private school vouchers from the current version to a prorated award for families that make over 450% of the federal poverty levels over minority opposition.

Additionally included in the final version is much disputed SB 117, which will create Constitutional study centers at five public colleges and universities, although the institutions that will host these centers have yet to be named. The nature of the content to be included in these centers also has yet to be disclosed.

State department of education reorganization

Part of the recently approved Fiscal Year 2024-2025 budget is a plan to restructure the State Department of Education.

Effective the first week October, the



State Department of Education will shift from the oversight of the State Board of Education, which a is led by the State Board's chosen Superintendent, to a yet-to-be-named Governor appointed director of the newly created Department of Education and Workforce. Under the new provision, the Department of Education will be renamed the Department of Education and Workforce moving forward. The new reporting structure transfers leadership from the State Superintendent of Public Instructions to the newly created cabinet position.

The approval of the new bill clarifies the status of the State Board of Education, which had been murky during the negotiation process. The Board will resume its search for a new State Superintendent. Under the reorganization, the State Superintendent will serve more as a legal advisor than the head of a state agency. Members of the Board of Education expressed concern about finding a suitable candidate to fit the position given the new responsibilities and comparably low salary.

The 2023-2024 school year Open Assurance survey opens on July 15th. All inspections and open assurance documents are required to be uploaded to the survey prior to the deadline.

Schools new to OSS sponsorship and schools opening new facilities or spaces must also complete the ODE required opening assurances form to be confirmed with the sponsor and submitted no later than 10 business days prior to the school's first day of school. Literacy learning groundwork found in Ohio early learning and development standards

Updates in the Language and Literacy domain of the <u>Early-Learning and Development Standards</u> align with <u>Ohio's Plan to Raise Literacy Achievement.</u>

The Language and Literacy domain focuses on language, communication, and early literacy skills for the birth to preschool age group, including language and communication, phonological awareness, print awareness, and emergent writing. These standards illustrate how young children develop literacy skills through listening, speaking, building vocabulary, comprehending stories, recognizing sounds in words, learning the alphabet, and developing basic writing abilities. Both caregivers and educators support the development of these skills, which are the groundwork

for future learning and literacy through everyday interactions.
