WHAT IS THRESHOLD COST REIMBURSEMENT?

Reimbursement for the 2022 – 23 school year for special education students in disability funding categories 2 – 6. Students in pre-k through grade 23 whose cost to educate exceeds the minimum threshold established by the Ohio Revised Code.

The program had been previously named Catastrophic Cost Reimbursement.



Threshold Amounts

Disability Funding Categories 2, 3, 4 or 5: \$27,375



Disability Funding Category 6: \$32,850



KEY PROGRAM INFORMATION

- The calculation spreadsheet is required.
- No additional documentation is required but could be requested by the area coordinators.
- Recommended send completed calculation spreadsheet to your area coordinator for review prior to uploading the student applications.
- Recommended start early and district staff work together as a team.

IDENTIFYING ELIGIBLE STUDENTS

Using the FTE Detail Report at year-end for 2023.

- ❖ Hide all columns except D, I, Q, V, AC and AD.
- Filter I & V to districts IRN.
- Filter AD for only codes 2-6.
- Sort Q by FTE from highest to lowest.

EXCESS COST STUDENTS



Excess Cost					
Excess cost certification amount is used for contracted education program cost, enter the excess cost certification amount (cost to educate) on the excess cost certification. Instructional supplies, instruction equipment, and operations support cost will not be added to the total cost to educate if student has contracted education					
program cost.

EXCESS COST STUDENTS

- Resident students
- Approved applications
- Cost to educate close to the threshold
- Administrative cost will be added to the cost

TIP: Sort function within the excess cost system



CONTRACTED EDUCATION PROGRAM STUDENTS

- Not educated within the resident district facilities
- Total education is contracted by a 3rd party
- Different from students that have contracted related services



IN-DISTRICT STUDENTS

Calculation spreadsheet designed to assist district staff in calculating the cost to educate each student.

- One-on-one aides
- Small class sizes
- Students with nurse
- Students with interpreter
- Specialized high-cost transportation

GENERAL CALCULATION SPREADSHEET TIPS

- The calculation spreadsheet will annualize the cost to educate automatically.
- Do not recommend using Google Docs.
- Double check if using copy/paste from another document/spreadsheet.
- Do not delete SSIDs or lines in the calculation spreadsheet.
