**WHOLE GRAIN CHERRY TURNOVER  
FROZEN  
(OHIO PROCESSED)**

***Product Description***

Individually wrapped 3.75oz fruit turnovers with whole grain crust using USDA fruit (Cherries/frozen).

***Pack Size***

Cherry turnovers are packaged 80 individually wrapped turnovers per shipping carton. Each case net weight 18.75 lbs.

***Yield***

Each case provides 80 serving of fruit turnovers; each turnover will provide 2 breads and ½ cup fruit serving in the NSLP and NSBP.

***Uses***

Cherry turnovers may be served in breakfast programs, snack programs or school lunch programs.

***Storage***

For optimal quality cherry turnovers should be stored frozen and never refrigerated. Cherry turnovers may be stored frozen (0°F) for up to six months. If thawed, cherry turnovers have a 4 day shelf life.

***Best If Used By\****

Cherry turnovers are best if used within six (6) months of production.

***Preparation***

Thaw on baking sheets at room temperature 2-3 hours before serving. Turnovers may be warmed or served at room temperature. Best if served within 24 hours after thawing.

**CRUST:**

Wheat Flour (Whole Wheat Flour, Enriched Wheat Flour Enriched with: Niacin, Iron (Reduced Iron), Thiamin Mononitrate, Riboflavin and Folic Acid), Water, Sugar, Partially Hydrogenated Soybean and/or Cottonseed Oil, Contains 2% or less of : Fat Replacers (Cellulose Powder, Maltodextrin), Salt, Monoglyceride, Dextrose, Sodium Propionate (To Retard Spoilage), Soybean oil, Vegetable Gums (Cellulose Gum, Agar), Corn Syrup Solids, Corn Starch, Calcium Carbonate, Calcium Sulfate, Carboxy Methylcellulose and Xanthan Gum.
