***Product Description***

Individually packaged 4oz. cups of reduced sugar, 100% vitamin C blue raspberry/applesauce using USDA apples.

***Pack Size***

Rockin' Blue Raspberry/Applesauce is packaged ninety six (96)-4oz. cups per shipping carton. Each case weights 26 lbs.

***Yield***

Each fruit cup will provide ½ cup fruit/vegetable credit in the National School Lunch Program or School Breakfast Program.

***Uses***

Fruit cups may be served in the breakfast program or the lunch program.

***Storage***

Fruit cups are shelf stable. The product may be stored between 45° - 80°F for up to eighteen (18) months. Product should never be frozen.

***Best If Used By\****

Fruit cups are best if used within six (6) months of receipt.

***Preparation***


Shelf stable fruit cups are ready to serve.
