ODE Report	<p>Operating Standards for Ohio Educational Agencies Serving Children with Disabilities Update The SBOE Achievement Committee discussed the proposed changes to the Operating Standards. The Committee approved the proposed changes moved a resolution of intent to adopt the amended rules to the full Board. The expected timeline for adoption is May, 2014 and Implementation by July 1, 2014. Guidance documents will be updated over the summer. The diverse group of stakeholders that included parent attorney's, districts attorneys, special education directors, parents and advocates. Short term and long term changes proposed. Stakeholders recommended removal of the 2nd tier of the due process system, to move to a one-tier system.</p> <p>Concerns regarding the hearing officers were raised. Need for standard procedures, review of current hearing officers, search for new officers. Hearing officers have been informed of possible changes and feedback has been requested. A summary of the proposed changes discussed during the meeting was sent back to the stakeholders along with long term and short term goals.</p> <p>More stakeholder groups will be created to review the other dispute resolution processes (Mediation, IEP Facilitation, Complaints). County Board Administration rule contains behavior support policies and procedures. Proposing that this rule be pulled out into its own separate rule. Contains principals of positive behavior support, lists prohibitive measures and lists restricted measures.</p> <p>Senator Lehner has written legislation on seclusion and restraint that has not yet been proposed. The language adds a requirement for the seclusion and restraint law/rule to apply to community schools.</p>

Feasibility of completing these questionnaires in the classroom or in the home.</p> <p>Students with Disabilities in Foster Care – Unmet Need Reviewed a sample program from Cincinnati Public Schools called “ Kids in School Rule!” Reviewed a memorandum of understanding related to data sharing across agencies.</p> <p>Recommendations: Set up a process to communicate quarterly between agencies around students in foster care; EMIS identifier of foster children, include general education in the conversation, this isn’t just a student with disability issue, recruitment of surrogate parents, training for judges around foster care and the educational needs of children.</p> <p>Department of Developmental Disabilities Guidance on Seclusion and Restraint Reviewed the language in the proposed rule, items K (Timeout involving individuals are children) and J (individuals in school settings). No changes were recommended.</p> <p><u>General Supervision Ad Hoc Committee</u> Prior Written Notice (PWN) and Waiver Application Recommendations:</p> <ul style="list-style-type: none"> • Definition of PWN placed in the Q&A. The word prior is confusing. PWN is not the same as an invitation. • Suggestion-require signature on PWN.

<p>SAPEC Learning or Information Items:</p> <p>Ohio's Special Education Research Study</p>	<p>Ohio's Special Education Research Study - Karen Sanders, Researcher <i>Handout – Ohio Special Education Research Project Executive Summary October 2013</i> <i>PowerPoint</i> Full reports can be found at www.oeecd.org.</p> <p>Funded by the Ohio Department of Education, the Ohio Special Education Research Study began in the fall of 2012 through the Ohio Coalition for the Education of Children with Disabilities (OCECD). The purpose of the study was to enhance understanding of the educational achievement of students with disabilities in Ohio with a particular focus on the reasons (best practices) that help shape various levels of achievement among similar (same typology) schools. Cross-typology analysis was used to identify those programs and practices common to high-achieving and low achievement school districts regardless of demographic and geographic characteristics. The process used to conduct the study was shared.</p> <p>Recommendations for Practice:</p> <ul style="list-style-type: none"> • Develop leadership capacity for implementation of evidence-based practices
