3. **Eligible service providers participating in waiver and affirmation that they are in good standing:**

**Any School Food Authority in good standing approved by the Ohio Department of Education, Office of Integrated Student Supports for the National School Lunch Program operation during the 2020-2021 school year.**

**School food authorities that would fall under this waiver would follow USDA and Ohio Department of Education guidance.**

4. **Description of the challenge the State agency is seeking to solve, the goal of the waiver to improve services under the Program, and the expected outcomes if the waiver is granted. [Section 12(l)(2)(A)(iii) and 12(l)(2)(A)(iv) of the NSLA]:**

**In school year 20-21 due to COVID-19, Ohio schools will have drastically modified school schedules where some children may be online, some children may be in school partial day, some children may be in school a full day and all children might be online. The modifications in school schedule and social distancing of children is in attempt to minimize the exposure and spread of COVID-19. Additionally, many schools and school districts are implementing a no visitors policy for the 2020-2021 school year to further reduce the exposure and spread of COVID-19.**

**This waiver is a request to continue the suspension of onsite monitoring to support social distancing and respect the no visitors policies of schools by allowing the completion of administrative reviews through an off-site, virtual mechanism.**

- 5. Specific Program requirements to be waived (include statutory and regulatory citations). [Section 12(l)(2)(A)(i) of the NSLA]:**

The Ohio Department of Education is requesting a waiver of school meals onsite monitoring requirements included at 7 CFR 210.8, 210.18 and 220.8(h) and the requirement to complete the onsite portion of the administrative review during the school year the review was begun at 7 CFR 210.18(c).

- 6. Detailed description of alternative procedures and anticipated impact on Program operations, including technology, State systems, and monitoring:**

If approved, the Ohio Department of Education will provide technical assistance to school food authorities that will undergo an administrative review in 20-21 of which a virtual observation will occur. There are no expected impacts on technology, state systems or monitoring.

- 7. Description of any steps the State has taken to address regulatory barriers at the State level. [Section 12(l)(2)(A)(ii) of the NSLA]:**

There are currently no State level regulatory barriers related to this specific issue.

- 8. Anticipated challenges State or eligible service providers may face with the waiver implementation:**

At this time, the Ohio Department of Education does not anticipate challenges from the establishment of this state-wide waiver at the state or sponsor level. Rather, it is anticipated the waiver will support social distancing while maintaining program integrity by continuing monitoring activities of program operations offsite.
