Local Meal Charge Policy

All school food authorities (SFAs) operating the National School Lunch and/or School Breakfast Program must develop a meal charge policy

SFAs have discretion in developing the specifics of their policies



USDA Requirement: Record Keeping



SFAs must provide the policy to the State agency during the Administrative Review



SFAs must maintain documentation of policy communication methods

How and when will families be notified of the policy?

How and when will families transferring to the SFA mid-year be notified of the policy?


How will staff members responsible for policy enforcement be notified of the policy?


Prevent Unpaid Meal Charges

Reach All Eligible Children


- Provide application assistance, especially for families with language or literacy barriers
- Improve direct certification systems



Reach Children Mid-Year



Remind families they may submit an application at any time




Determine whether children **may be eligible** for free meals



Reach Children Mid-Year








School does not charge reduced-price fee







Provide Payment Reminders

Encourage families to track spending

Remind families of a low balance **BEFORE** the account goes negative

Make sure contact information is current



How do you prevent lunch shaming?





Prevent Lunch Shaming

Communicate privately with families about a child's outstanding balance

Communicate payment reminders directly and discreetly to adults in the household

Send payment reminders in a plain, white envelope



Avoid Singling Out Students

Do not throw a child's meal in the trash if they are unable to pay! **Do not** identify children with meal charges using hand stamps, stickers, or other visual markers!



Aim for High Quality Alternate Meals

Do not serve alternate meals that single out children with unpaid meal charges!

Overcoming Unpaid Meals Challenges



Non-Federal Resources



School district's general fund





Charitable Funding Resources

Community Funding – Kiwanis, United Way, school volunteer organizations, other local charities

Random Acts of Kindness Funding – funds placed in a general lunch account



Charitable Funding Resources

School Fundraisers

End of Year Donations – families with funds to donate



How did you develop a distribution plan to ensure funds are shared equitably between schools and among children?





Develop a Distribution Plan

Work with school counselors or social workers to determine which children would benefit from short-term funding

Develop a repayment plan for families relying on funds

Look at whole picture – cost of living in the community and personal hardships




What funding strategies do you avoid?






Funding Strategies to Avoid



USDA FNS does not view alternative funding as long-term solution



Teachers, food service professionals, cashiers and other school staff members should never be expected to pay for children's meals



Clarification on Collection of Delinquent Meals Payment

Unpaid Meal Charges = Delinquent Debt

Delinquent if considered collectable

Debt remains on accounting documents until collected or written off



Collection is Allowable Expense

Cost of collecting debt is allowable for School Foodservice Funds

Establish a Delinquent Debt Policy

Reasonable timeframe and methods

Unpaid meal charges may be carried over at end of school year



Establishing Delinquent Debt Policy

Focus on adults, not students

Consider if benefits of collection outweigh costs incurred

Policies regarding the collection of unpaid meal charges should be in the meal charge policy



Reclassifying Delinquent Debt as Bad Debt

Uncollectable and no further collection efforts

No longer considered an asset and must be written off as operating losses

Related collection costs and legal are now unallowable

Repayment must be restored with non-federal funds


