HIGHLIGHTS OHIO GRADUATION TEST PRELIMINARY RESULTS MARCH 2005 TEST ADMINISTRATION

INTRODUCTION

The Ohio Graduation Tests (OGT) supersede the Ninth-Grade Proficiency Tests as a high school graduation requirement for the class of 2007 and beyond. The tests were developed in compliance with the requirements of Ohio Senate Bill 1, Ohio House Bill 3, and the *Federal No Child Left Behind* Act.

The tests were administered during the two weeks beginning Monday, March 14, 2005, to 10th graders in Ohio public schools, community schools and chartered non-public schools. This was the first administration of the writing, science and social studies tests; the reading and mathematics tests were administered for the first time in March 2004.

A provision of Ohio House Bill 493, signed into law by Ohio Governor Bob Taft in February 2005, allows students who are required to achieve proficient scores on the Ninth-Grade Proficiency Tests in order to graduate to meet testing requirements by achieving a proficient score on the OGT in the same subject. For this reason, some students in grades 11 and 12, as well as some students whose classes have already graduated, attempted the OGT.

The performance standards for the OGT are based on the recommendations of Ohio educators, parents and community members. The standards for the writing, science and social studies tests were set after the March 2005 administration; the standards for the reading and mathematics tests were set after the March 2004 administration. Standards for future forms of the tests will be maintained through a statistical process called equating. In addition to meeting the rigor of the local district curriculum, students must demonstrate performance at the proficient level or above in all five subject areas to meet graduation requirements.

The highlights were based on the preliminary results of the March 2005 test administration. Schools and districts have not verified those results. The final figures may be different due to appeals, late scoring and other changes.

TOTAL STUDENTS TESTED

Table 1 shows the total number of grade 10 students that took the OGT in March 2005 by subject and school classification. Community schools are included among the public figures.

PRELIMINARY TEST RESULTS FOR PUBLIC SCHOOLS

Table 2 presents a summary of 10th -grade student performance on the March 2005 OGT. Students with Individualized Education Plans (IEP) and/or Limited English Proficiency (LEP) are included in the figures. Nearly 64 percent (83,730 of 131,562; 63.6 percent) of public 10th graders who attempted all five tests achieved a result of proficient or above on all five tests. Community school data are included in the public school totals.

PRELIMINARY TEST RESULTS FOR NONPUBLIC SCHOOLS

Table 4 presents a summary of 10th -grade student performance on the March 2005 OGT. Students with Individualized Education Plans (IEP) and/or Limited English Proficiency (LEP) are included in the figures. More than 87 percent (11,952 of 13,721; 87.1 percent) of non-public 10th graders who attempted all five tests achieved a result of proficient or above on all five tests.
