Annual Report on the 22+ Adult High School Diploma Program Provider Performance Report – Fiscal Year 2022

Executive Summary

In Ohio, there are approximately 875,000 working age adults that do not have a high school diploma. Adults without a high school diploma are at a disadvantage when competing for Ohio's in-demand jobs. In response, the Ohio Department of Education developed programs for adults to earn a high school diploma, and in 2014, the 22+ Adult High School Diploma program was implemented to allow adults 22 or older to earn a high school diploma. Participants are required to complete this credit recovery competency-based program within two years and the school district of residence at the time of enrollment will issue the high school diploma and transcript.

Ohio law requires the Department to report each provider's performance related to the program. The Department is required to publish the report on the <u>Department's website annually</u>. The purpose of the report is to provide an overview of each provider's performance based on the following measures:

- Average number of credits earned;
- Percentage of participants completing 40 percent or more of credits necessary to earn a diploma during year one;
- Number and percentage of participants who earned their diploma, withdrew and/or returned their second year; and
- Performance on state-required content assessments and other relevant work-readiness assessments.

The Department and providers use this report to inform stakeholders of each provider's progress and make improvements to ensure participants successfully complete the program. Providers are required to maintain a diploma rate of 40 percent or higher and ensure participants complete 40 percent or more of credits during year one of the program. Participants that complete 40 percent or more of their necessary credits during year one are more likely to earn a diploma.

Key findings from this year's report include:

- The statewide diploma rate was 52 percent.
- 31 providers met the 40 percent minimum provider performance level for percentage of diplomas awarded by a 22+ program based on a two-year cohort set by the State Board of Education.
- 62 percent of participants completed 40 percent or more of their credits necessary to earn a diploma in year one statewide.
- 3,471 participants enrolled in the 2021-2022 school year.
- On average, participants had earned 17 credits prior to enrollment and needed to pass one state graduation test.

Ohio is committed to offering programs for adults to earn a high school diploma. This report provides stakeholders with the necessary data regarding the performance measures of the 22+ Adult High School Diploma Program.





Introduction

Ohio law¹ allows adults ages 22 and over a credit recovery opportunity leading to a high school diploma. Adult learners need to only meet minimum graduation requirements set by the State Board of Education when the student initially entered the ninth grade. The program is free to adults who are at least 22 years old, live in Ohio and do not have a high school diploma or the certificate of high school equivalence.

Educational institutions eligible to offer the 22+ Adult High School Diploma include:

- Community schools that operate dropout prevention and recovery programs;
- City, local or exempted village school districts that operate dropout prevention and recovery programs;
- Joint vocational school districts that operate adult education programs; and
- Community colleges, university branches, technical colleges or state community colleges.

Participant Overview

In the 2021-2022 school year, 3,471 participants enrolled in the program. The average age of participants was 34 years old. The average number of credits earned prior to enrollment was 17 and the highest grade completed was grade 12. Table 1 identifies participants percentages of the race/ethnicity and language spoken.



FY21 Student and Provider Performance Data

Percentage of Diplomas Awarded (Diploma Rate)

Ohio Administrative Code 3301-45-06(E) requires the State Board of Education to establish a minimum provider performance level for percentage of diplomas awarded (diploma rate), which became effective on July 1, 2016.

The State Board of Education adopted a 40 percent minimum provider performance level for percentage of diplomas awarded by a 22+ program based on a two-year cohort that is lagged one year.

Measure Description

Ohio Revised Code <u>3314.38</u>, <u>3317.23</u>, <u>3317.24</u>² and <u>3345.86</u> allow for a student to have up to two consecutive school years to earn a diploma. To account for this, the percentage of diplomas awarded is a cohort award rate of two years.

To calculate the minimum performance level for percentage of diplomas awarded, the Ohio Department of Education tracks the success of students over two fiscal years. The denominator (cohort) includes any student who was accepted into the program for the first time in the fiscal year, regardless of whether the student withdrew, did not proceed with the program or graduated in that fiscal year. The numerator is any student from the cohort that earned a diploma in that fiscal year or the next consecutive fiscal year.

Technical Calculation

- **Denominator:** The denominator, or cohort, is created by determining those students who are entering the program for the first time for that given fiscal year (Application Types = "New"). In addition, those students must have been accepted into the program (Status = "Accepted," "Terminated" or "Requirements Passed").
- Numerator: The numerator includes:
 - For the first fiscal year, students from the cohort who have the application type "New," and status "Requirements Passed;" and
 - For the second fiscal year, students from the cohort who have the application type "Renew" and status "Requirements Passed."

The diploma rate is calculated by fiscal year as described above. It is important to note that as participants have two years to complete their requirements, the final diploma rate is lagged one year. The FY21 diploma rate includes participant information from 2020-2021 and 2021-2022. This report includes the final diploma rate for FY21.


Diploma Rate Calculation for FY21 Rate

For FY21, 1,665 students were accepted into the program for the first time. 667 students met the requirements, and 998 are eligible to return to the program in 2022.

In FY22, 560 (56.1%) of the remaining 998 students renewed, while 438 (43.9%) students dropped out or never renewed. Of those 560 students, 192 (34.3%) met requirements in 2022.

Diploma Rate by Provider

The data below reflects the diploma rate, by provider, for the cohort of students who entered the program for the first time in FY21 (at any point in the 2020-2021 school year). A student enrolled in October 2020 is counted one full year in the program in the same school year on June 30, 2021.

One-Year Credit Completion Rate

Measure Description

The one-year credit completion rate is a measure reported at the provider level. To calculate the one-year credit completion rate, the Department tracks the credits earned by students over one fiscal year. At the beginning of the program, each student establishes the number of credits he or she needs to earn a diploma. The first calculation determines the completion rate at the individual student level by taking the number of credits completed divided by the number of credits needed to earn a diploma. The one-year credit completion rate at the provider level is then created by calculating the number of students in the cohort at each provider divided by the students who met the 40 percent threshold established in state law.³

The rate does not include those participants who only need to pass assessments, as it focuses solely on credit completion.

Technical Calculation

- **Denominator:** The denominator is created by determining those students who are entering the program for the first time for that given fiscal year (Application Type = "New").
- Numerator: The numerator includes:
 - Students from the cohort who have the application type "New" and met the threshold of completing 40 percent of credit hours required (reported in "Plan to Complete").

One-Year Completion Rate for 2022 Cohort

Table 4 below captures the one-year credit completion rate by provider. This measure reports the percentage of participants completing 40 percent or more of their credits necessary to earn a diploma. The chart shows 62 percent of participants earning 40 percent or more of their credits in the first year. Participants that complete 40 percent or more of their necessary credits during year one are more likely to earn a diploma. As the diploma awarded rate captures two years of data as noted above, this completion rate provides a snapshot of performance for the 2022 cohort.

Average Credits Earned Per Student

The average credits earned per student varies as students can enter the program needing up to 15 credits. Other students previously may have earned all needed credits and only need to pass the Ohio Graduation Tests (OGT) at the time of enrollment. On average, new students had earned 17.7 credits prior to enrollment and each student needed to pass one state graduation test. Table 5 below provides the average credits earned by all students participating in the program during the 2021-2022 school year — regardless of cohort assignment. To calculate the average credits earned per student, the total number of credits completed by all students is divided by the number of students participating.

- Performance on state-required content assessments and other relevant work-readiness tests (such as WorkKeys or technical skill tests).
