## **Executive Summary**

Named for State Representative and special education advocate Jon Peterson, the Jon Peterson Special Needs Scholarship was created in 2012 by the Ohio General Assembly. The program awards scholarships to parents of children in grades kindergarten – 12 who have been identified as having a specific disability. Students are evaluated, an Evaluation Team Report (ETR) is created, and an Individualized Education Program (IEP) is developed, which details the required special education and/or related services for the student.

The Jon Peterson Scholarship (JPSN) allows a parent to choose the school or educational setting that best meets their child's needs. Parents may select from several types of approved program providers. Children may attend a chartered nonpublic school, receive services from a private business or organization, or attend a public district that is not their public school district of residence.

Once eligible students are awarded a scholarship, they must meet the assessment requirements per their grade level to renew the scholarship annually.

The JPSN program is authorized under <u>Ohio Revised Code 3310.51</u> and <u>Ohio Administrative</u> Code 3301-101.

This report outlines student participation and expenditures for fiscal year 2023. Key findings include:

- During the 2022-2023 school year, 8,186 students utilized the Jon Peterson Special Needs Scholarship program.
- For the last 10 years, the growth of the Jon Peterson Special Needs Scholarship has steadily increased from 336 to 439 approved providers participating in the scholarship program.
- Students enrolled in the JPSN scholarship program during the 2022-2023 school year covered 487 school districts in Ohio. This represents nearly 80 percent of Ohio's school districts.

## **Scholarship Award Categories**

The Jon Peterson Special Needs Scholarship provides students with a scholarships based on each student's disability category. Thirteen disability categories recognized by the federal Individuals with Disabilities Act (IDEA) are organized into six funding levels. Maximum funding levels for each category of disability and calculations are included in <a href="Section 3317.022">Section 3317.022</a> of the Ohio Revised Code. Scholarship funds may be used for tuition or related support services.





## **Program Participation and Expenditures**






#### 2022-2023 Student Participation

During the 2022-2023 school year, 8,186 students received services from 439 approved providers through the Jon Peterson Special Needs Scholarship program. The program drew students from 487 districts across Ohio.







#### **DISTRICT OF RESIDENCE**


Students enrolled in the JPSN scholarship program during the 2022-2023 school year covered 487 school districts in Ohio. This represents nearly 80 percent of Ohio's school districts. A breakdown of students per school district utilizing JPSN can be found <a href="here">here</a>.

#### **Statewide Expenditures**

Prior to the 2021-2022 school year, funds used to award scholarships were deducted from the district in which the student was entitled to attend school, known as the district of residence. House Bill 110, passed in 2021, eliminated the "district deduction" mechanism and established direct funding of scholarship programs through the Department of Education and



Workforce. Total expenditures for the JPSN program during the 2021-2022 school year sum to \$81,773,133.70.



# Jon Peterson Special Needs Program Providers

The JPSN program had 439 approved providers in the 2022-2023 school year. Organizations that are represented in the program include chartered nonpublic schools and private providers. A list of providers and their contact information can be accessed on the Department's website.
