### Shelby Robertson:

- Update Work-Based Learning information– waiting for communications tech edits and format
- Clarification on fiscal year for Perkins reporting – United States Department of Education said document is incorrect. First reporting year is fiscal year 2021 not fiscal year 2020.

### Leah Amstutz:

- Discussion on completion
  - Partial or full credit – how credit is awarded is a local decision.
  - Are students being left out of measure due to this?
  - Discussion of Ohio Department of Education simulations to determine credit awarded vs. seat time.



- 14,000 students met 75% seat time, but were not awarded partial or full credit.
- 7300 earned partial or full credit, but did not meet 75% seat time.
- Ohio Department of Education recommending “participated in 75% of course or earned full or partial credit”
  - Ensure that the students listed above are pulled into the calculation

Krista Gearhart – Will the Ohio Department of Education reports identify students that are not identified correctly?

- Exp. Student moves in March (completed 75% of course), will this student show up on concentrator
- Leah will follow up with Education Management Information System.

Ron Matter – Can a practice be run as a trial 1 year ahead to see what the data might look like?

Amy Pognacsik – Can you confirm that this current school year will be reported under the Perkins V definitions?

Marcy Roll – Wants to confirm that we will provide a report this year to compare how students have been reported.

Krista Gearhart – Wants to make sure that post-placement measure will be reviewed as this definition of completion is rolled out.
