Approval Criteria

In the case of a new program, the cost to begin the program.



Oct. 1, 2013 – HB 59 Sec. 3317.161 takes effect

Community Schools and STEM Schools are assigned to Career-Technical Planning Districts (CTPD).



By March 1, 2014 – All CTE programs operated by Community or STEM schools newly assigned to a CTPD will be approved or disapproved by the CTPD lead district.

This applies to already approved and new applicants



By March 15, 2014 – Any appeals generated by programs not approved or not acted upon by the CTPD lead district must be received at ODE.



By May 15, 2014 – All appeals must be decided by ODE for programs that seek design and funding approval for the 2014-15 school year (FY2015).



FY2015 and Career-Based Intervention

Per HB 59 Sec. 265.500, All Career-Based Intervention programs shall be reviewed using the quality program standards developed by ODE.

FY2015 and Career-Based Intervention

ODE will decide based on this review whether to approve or disapprove the program for funding for the following five fiscal years, and shall notify each district, community school or STEM school of its decision by May 15, 2015.

FY2015 and Career-Based Intervention

Any ODE approved Career-Based Intervention program subject to review in FY2015 shall retain its approval status during that fiscal year.
