
# **Career-Technical Education Secure Data Center Reports**

Starting in 2021, the Ohio Department of Education began developing and publishing reports within the Ohio Department of Education's Secure Data Center (SDC) to support the Career-Technical Education Report Card. Many reports that were previously published in the Data Collector have been replaced by Secure Data Center reports. These reports contain detailed data for the measures and components of the Career-Technical Education EMIS reporting and performance on CTE accountability measures.


### Where is the Secure Data Center?

The Secure Data Center is an OHID application located within the Report Portal tile on the OHID website.





The Ohio Department of Education has developed both Career-Technical Planning District (CTPD) and CTPD Member District Reports. Secure Data Center reports focusing on Career-Technical Education are available within the Career and Technical Education and Local Report Card tiles of the Secure Data Center.



## Who has access to the Secure Data Center?

Staff with one of the following roles in the Ohio Educational Directory System (OEDS) have access to the Secure Data Center:

- Superintendent
- Superintendent Designee
- Secure Data Center Standard Level Access
- Secure Data Center Student Level Access (Available only to member districts that are traditional public districts, Community or STEM schools)

Staff assigned one or more of the roles above at the CTPD IRN would have access to CTPD-level reports. Staff assigned one or more of the roles above at a member district, including the CTPD lead district, would have access only to the member district reports for their respective district. Staff assigned Secure Data Center roles in both the CTPD, and a member district would have access to both the CTPD and their



respective district reports. The staff member will be required to select an organization when they log into their account and will then see reports specific to that organization.
