Charter School Program (CSP) Grant

In 2015, Ohio received a \$71m grant from the U.S. Department of Education to significantly increase access to high performing public charter education opportunities for Ohio's most disadvantaged boys and girls.

Advisory Committee

MEMBERS

The Committee is composed of individuals from key stakeholder groups in Ohio representing nonprofits with relevant expertise in community school sponsor quality; state community school organizations; institutes of higher education with expertise in performance management; high-quality community school management organizations; organizations that represent the interests of families and children enrolled in community schools; and a national organization with expertise in community school oversight and quality

MEETING DATES

The Committee shall meet on at least semi-annual basis with the first meeting occurring thirty days prior to the department publishing its first request for application for the CSP Grant. Thereafter the Committee shall meet in June and December of each year. Dates will be forthcoming

Public Charter School Program Grant

GRANT PURPOSE

The purposes of the grant are: to support the opening of high-performing site-based community schools; provide for more site-based community schools serving disadvantaged students where no effective options exist; and to increase accountability and autonomy for community school sponsors accountable to protect student trust and public investment in Ohio's community schools.

TYPES OF GRANTS AVAILABLE

Two types are available: planning subgrants, intended for groups of individuals who are developing a high-performing community school; and implementation subgrants for community schools in their first and second years of operation. Up to \$100,000 is available for planning subgrants and up to \$350,000 for first year implementation subgrants and up to \$250,000 for the second year implementation subgrants

GRANT ELIGIBILITY

To be eligible, the planning subgrant applicant must have entered into a Preliminary Agreement with a sponsor rated "effective" or "exemplary" overall on the most recent sponsor evaluation. Similarly, a community schools whose sponsor was rated "effective" or "exemplary" overall on the most recent sponsor evaluation are eligible to apply for implementation subgrants.

GRANT APPLICATION AND SUBMISSION PROCESS
