DOPR SCHOOL DEFINITION (OAC 3301-102-10)

A dropout prevention and recovery school is one to which any of the following applies:

• (1) Any community school that operates a drug recovery program in cooperation with a court; or



DOPR SCHOOL DEFINITION (OAC 3301-102-10)

(2) Any community school in which the majority of students are enrolled in a dropout prevention and recovery program operated by the school that meets the following criteria:

- Serves only students ages 16-21
- Students are at least one grade level behind their cohort age groups or experience crises that significantly interfere with their academic progress
- Program requires students to attain at least the applicable score designated for each of the assessments
- The program develops an individual career plan for the student that specifies the student's matriculating to a two-year degree program, acquiring a business and industry credential, or entering an apprenticeship;
- Program provides counseling and support for the student related to the plan; and
- The program's instructional plan demonstrates how the academic content standards are taught and assessed; or



DOPR SCHOOL DEFINITION (OAC 3301-102-10)

• (3) Any conversion community school whose sponsoring district has received a waiver from having the school's academic data rolled up into the district's local report card because the school primarily enrolls students between sixteen and twenty-two years of age who dropped out of high school or are at risk of dropping out of high school due to poor attendance, disciplinary problems, or suspensions.



DOPR REPORT CARDS (ORC 3314.017)

- DOPR community school can receive a DOPR report card, rather than the standard report card, provided the school meets the criteria
- Still subject to federal law and state continuous improvement, corrective action plans
- Rules prescribe performance levels and benchmarks for performance indicators on the DOPR community school state report card
- The Department must use simulations and gather and analyze data from prior school years to establish benchmarks
- Ratings: "Exceeds standards," "Meets standards," or "Does not meet standards"



DOPR CLOSURE (ORC 3314.351)

- Dropout recovery community schools that are designated as not meeting standards for three consecutive years on their report card are subject to closure
- The governing authority and sponsor of a permanently closed dropout recovery community school must still comply with DEW rule for reporting data to the department, handling student records, and distribution of assets – 3314.015(E)
- DOPR schools are not subject to closure for their first two years of operation – 3314.351(C)



RECENT CHANGES TO LAW (HOUSE BILL 33)

- DOPR credential-only programs considered a category one career-tech ADM and full-time for funding purposes, and allows schools to use such funds for emergency or career support for students
- Requires DOPR schools to administer end-of-course exams online or on paper, and that there be extended windows in which testing may occur
- DEW to consult stakeholders and use data from prior years in establishing benchmarks for DOPR report cards
- DOPR Advisory Council created
- DOPR school requirements must be formally adopted in Administrative Code

PREVIOUS DOPR RECOMMENDATIONS

• Overview:

- The State Board of Education DOPR Work Group issued eleven recommendations
- Five of the recommendations were subsequently enacted
- The use of Credit Flexibility was available to DOPR schools at the time the recommendations were issued



PREVIOUS DOPR RECOMMENDATIONS: IMPLEMENTED

Establish an Advisory Council

Appoint a Liaison

Require rulemaking for requirements/rescind existing guidance

Revise blended learning definition

Permit school location beyond "challenged" school districts



PREVIOUS DOPR RECOMMENDATIONS: NOT IMPLEMENTED

Change the name of schools from dropout prevention and recovery

Revise the DOPR report card – more accountable measures

Permit EOC administration on demand – STAR assessment windows were expanded

Extend age range from 16-21 to 13-21

Direct funding of transportation

QUALITY COMMUNITY SCHOOL SUPPORT GRANT



QUALITY COMMUNITY SCHOOL SUPPORT GRANT: ELIGIBILITY

- Sponsor rated effective or exemplary
- Greater than 50% economic disadvantage
- School performance index greater than the district in which the school is located for two most recent years
- Progress rating of 4 or 5 stars on most recent report card
- No progress rating required for DOPR schools



QUALITY COMMUNITY SCHOOL SUPPORT GRANT: ELIGIBILITY

- Two DOPR schools received Quality Grant funding this year for the first time
- Franklinton High School and Old Brook High School
