CALL MEETING TO ORDER

APPROVAL OF MINUTES

Cris Gulacy-Worrel made a motion to approve the December meeting minutes. Adam Clark seconded the motion. January 2025 minutes were approved by a vote of 8-0.

RESOLUTIONS

Colleen Grady provided the list of resolutions previously adopted by the Council.

- Adjusting the DOPR age range to 14-24
- Additional pathways (revise OAC)
- Funding for students ages 22-24
- Fully fund online DOPR supplement (has been put into law)
- Revise online funding formula to include DPIA
- Eliminate disproportionate payment of Catastrophic Aid
- Supplemental funding for DOPR transportation

The Council discussed issues between community schools and career tech planning districts. The Department will provide information regarding community school/CTPD participation and expenditure data. The Council also discussed a possible resolution regarding facility funding for expansion and start-up funding.
