POTENTIAL CHANGE - Am. Sub. HB66 (State Biennial Budget Bill)

The proposed biennial budget for 2006-2007 includes a recommendation to select a single date by which a child must be 5 years old to be admitted to kindergarten and 6 years old to be admitted to 1st grade. If this recommendation is approved, the 4.1.3.3 Birthdate Deadline for Kindergarten Entrance element on the District General Information Record – October can be eliminated.

CANCELLED 8/19 - The Ohio Department of Education is not pursuing this option at this time

POTENTIAL CHANGE - No Child Left Behind Act

On April 7, 2005, the USDE announced the development of a new approach to implementing NCLB. One of the first provisions of this new approach would permit states to allow students with disability conditions who have persistent academic disabilities (but who are not significantly cognitively impaired to warrant the administration of an Alternate Assessment) to take a modified alternate assessment based on modified achievement standards. In Ohio, this could include allowing these students to take the current statewide assessments administered at lower grade levels than the student's current grade level placement (referred to as "off year test administration"). States will be allowed to include proficient scores from such assessments in making AYP decisions but these scores will be capped at 2% of the total tested population. Please note that this 2% is in addition to the 1% cap on students with the most significant cognitive disabilities that take the Alternate Assessments (ALT). This new flexibility could require the addition of options to the testing records and changes in reporting instructions.

FY07 CHANGES DUE TO AM. SUB. HB66

The following EMIS changes were included in Am. Sub. HB66 and will impact the FY07 school year. ODE staff are currently in discussion on the implementation of these potential changes and more information will be shared as part of the FY07 EMIS Change Process.

Potential FY2007 EMIS Changes Based on Am. Sub. HB66

FY07 CHANGE - Am. Sub. HB66 (State Biennial Budget)

The final biennial budget for 2006-2007 included a provision to move the statewide testing date from March to May, except for the Ohio Graduation Test. This change will impact the 2006-2007 (FY07) school year.

FY07 CHANGE - Am. Sub. HB66 (State Biennial Budget)

The final biennial budget for 2006-2007 included a provision to fund school districts based on two ADM counts. Payments for July through December shall be based on student counts during the first full week in October and payments for January through June shall be based on the average of student counts for the first full week of the previous October and the third full week in February. This change will impact the 2006-2007 (FY07) school year.

FY07 CHANGE - Am. Sub. HB66 (State Biennial Budget)

The final biennial budget for 2006-2007 included a provision to establish the Educational Choice Scholarship pilot program, which will allow students to attend chartered nonpublic schools if they are enrolled in a school building that has been rated in Academic Emergency during the most recent rating of school buildings published prior to the first day of July of the school year for which a scholarship is sought and in the preceding two years. This program is separate from the existing Cleveland Scholarship and Tutoring Program. This change will impact the 2006-2007 (FY07) school year.
