- Strict limitations on agency requests (90% and 100% scenarios)
- Rules for ODE exclude school funding formula and related line items.


March - June 2019:

July 1, 2019: FY20-FY21 biennium begins









Budget by Category



- Members of each workgroup will quickly review the information from their workgroup
- We will have approximately 10 minutes of whole-group discussion about each workgroup report

Today's Meeting

- Our focus today will be on the top 3 challenges/opportunities as determined by the workgroup members
 - In final activity, each workgroup member selected the top 2 or 3 most important items,
 - -Then selected the next 7 or 10 items
 - -Number selected based on total count of recommendations developed by the group
- Top ratings were given a weight of 3 and combined with count of "next" votes received
- Cannot compare rating totals across groups

Before the June 5th Meeting

- ODE staff will work to combine, where appropriate, the challenges and opportunities across workgroups
 - Challenges related to non-EMIS staff appear in all 4 workgroups
 - Training needs appear in all 4 workgroups
 Several other topics appear in 3 workgroups
- ODE staff will distribute a draft report in advance of the June 5th meeting, including
 - -Current status statements as a single introduction
 - -The top 12 challenges/opportunities
 - -Any other challenges closely related to the top 12

June 5th Meeting

- As one of our agenda items, ODE staff will present and move the draft report for council approval
- Subject to vote of the council, individual items in the set of 12 may be updated and/or removed
- Members may also suggest amendments to the report, including adding additional challenges/recommendations, subject to vote of the council



June 5th Meeting

- In general, ODE staff propose that between 12 and 16 challenges be included in the initial set of recommendations to the State Superintendent
- By the end of the meeting, the goal is for the council to vote to issue its first report
- Any recommendations not forwarded in this first report will be retained by the council
 - -Could be part of a future report
 - Could form the basis for future workgroups next year
 - May be implemented by ODE staff without recommendation if the opportunity to do so occurs

First Priority Challenge/ Opportunity for Improvement

Challenge

Short-term Opportunity for Improvement

EMIS Coordinators often need information in one place from multiple reports. There is no way to see everything about a single student in one place. Staff have to spend too much time on Vlookups or other types of merges before they can efficiently review data.

Determine combinations of data that would be most helpful and feasibility of adding pre-defined reports to join that data within the Data Collector. Long-term Opportunity for Improvement

Consider adding methods to join reports on-demand within the Data Collector. Determine if there is any way to add names to received files and implement functionality.

Create a report writer so that self-designed reports can be generated, which would help when dealing with auditors and civil rights data that must be sent to the feds.

The Assessment Missing Lists would be more useful if they accounted for more scenarios in which a district may not have an assessment for a student. Update the Assessment Missing Lists to include situations in which a student is accelerated or has taken alternate assessments. Evaluate adding new EMIS data that would enable all situations that impact missing list to be considered, making missing list 100% inclusive.

Sometimes an additional level 1 check or additional information on a report would simplify work locally to review and use the data. (Workgroup members suggested nearly 20 changes that would be evaluated in addition to any requested through the new process)

Challenges: Finance/Funding Reports

Challenges: Resources/Report Card

A member of the EMIS Advisory Council should be added to the State Board of Education's "combined" report card/accountability committee so that a data person can contribute to the discussions. Department Data Processing & ODDEX Workgroup: Recommendation Review

General Issues

- Earlier and more frequent feedback
- More notification about when checks are going to be available
- Training for other district staff to help them interpret EMIS data, as well as, understand the importance of their role related to EMIS data
- Easier to locate checks in the Data Collector
- Summative information about where they stand overall with data reporting

ODDEX

- Online training for multiple audiences in district for basic ODDEX navigation and relevance of information available
- Sortable headers in the Student Cross Reference (SCR)
- More student demographic EMIS data added to the History module
- Ability to upload a document in the Tuition module

ODDEX

- New open enrollment module to allow for verification of students who are open enrolled in and out of a district
- Improve ability to move between modules for the same student or to see selected data from one module in another module (e.g. History data in the Tuition module)
- Email notification when a comment is added to a flag

ODDEX

- Notification to districts of when CCP data is loaded
- Adding a requirement that contact information be entered and maintained in ODDEX
- Ability to extract more datasets out of ODDEX

Level 2 Reports

- Report showing which data is used for the payment
- Easier to find archived reports in Data Collector
- Improve Teacher Licensure Certification (TLC) report to make it easier to use
- Additional information in the FTE Detail report, such as LRE data, a student's total FTE, and the percent of time reported by other districts



Level 2 Reports

- New result code in the adjustments for a newly identified special education student
- Better documentation of what error codes mean, specifically fatal errors that cannot be corrected (e.g. out of state tuition or nondisabled preschool students) and whether different error codes or language would be helpful

Data Files and Other Data Processing

- Prepared for Success data file
 - -Drillable reports in the SDC
 - -Data checks to flag potential data to review
 - Additional training for district staff
- VLOOKUP alternatives
- CTE26 read-only access for EMIS Coordinators

First Priority Challenge/ Opportunity for Improvement

Challenge

Short-term Opportunity for Improvement Long-term Opportunity for Improvement

EMIS Coordinators find it challenging to give data checks to other district staff for assistance with collecting and correcting data. Other staff do not always understand the relevance of the information. Create multi-audience training/documentation for district staff to help them interpret EMIS data, as well as, understand the importance of their role related to EMIS data.

Second Priority Challenge/ Opportunity for Improvement

Challenge	Short-term Opportunity for Improvement	Long-term Opportunity for Improvement
Districts need more frequent feedback about data reporting during the collection.	When possible, provide general issue checks earlier in the collection and more often toward the end.	



Third Priority Challenge/ Opportunity for Improvement

The FTE Detail report does not display some information useful to correcting issues associated with data reporting. For example, a student's total FTE and the % of time reported by other districts.

Challenge

Short-term Opportunity for Improvement Long-term Opportunity for Improvement

Review information displayed in FTE Detail report to determine what additional data could be provided.

Consideration will be given to adding the LRE data, a student's total FTE, and percent of time reported by other districts.
