#### Report Distribution

A report is to be distributed weekly to any EMIS reporting entity where data meet the report criteria. It is to be generated during the weekly cycle and transferred to its contracted ITC for distribution. The output is to include district-level information in a single report file.

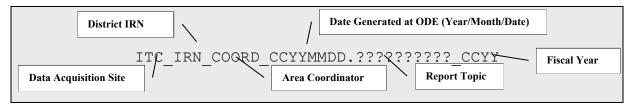

#### **Report Selection Criteria**

Records are selected from the Year End Attendance file if they have:

HOMELESS = "*A*", "*B*", "*C*", "*I*"

- STATE EQUIVALENT GRADE LEVEL = " "PS", "KG", "01"-"13", "23"
- ATTENDING/HOME STATUS starts with "1", excluding "16", "1F", "1I" or Attending/Home Status = "23", "24", "25"

# Report Layout/Sample

#### **Header Information**

The first area of the header describes information about the report generation. The upper left section names the program from which the report was generated and the data source. The middle information identifies the producer of the report and the report title. The upper right section states the date on which the report was generated, the page number, and the reporting period to which the report belongs.

The second area of the header pertains to the recipient of the report. It identifies the district for which the report was produced, its IRN and COUNTY, the ITC and AREA COORDINATOR of the district.

The last column header is the one for the total count of fields (2-6 for the grade level (field 1).)

#### **Detail Information**

Each of the columns contain HOMELESS condition counts and is listed horizontally, one column for each HOMELESS condition. Each of the GRADE LEVELS are listed vertically, one row for each grade. The counts are shown under their appropriate grade rows and homeless condition columns.

The right-most column is the Total by Grade, the sum of all of the columns for that row.

The totals at the bottom of the page sum each column of the report. The last number on the report is the total count of students reported at all grade levels for all homeless conditions.
