# LEVEL 2 VALIDATION ERRORS CATEGORY 1 EXPLANATION

The Level 2 Validation Errors, Category 1, identify data issues where a student has invalid or incorrect relationships reported between multiple entities. To remedy the errors, the Local Education Agency (LEA) should work with the other LEA to ensure that the Sent to and How Received IRNs and Codes are accurate, as well as ensuring that admission and withdraw dates for students moving into/from an LEA to another are not overlapping.

The errors contain the error code and description of the error, as well the Building IRN, Building Name, EMIS Student ID, Name, State Student ID, Reporting LEA IRN, How Received IRN, and Sent to IRN data elements.

#### **The Selection Criterion**

Students are excluded from the report where the Local Education Agency (LEA) reports:

- Received from LEA IRN = '999999', or
- Sent to LEA IRN = '999999', or
- How Received Reason Code = ('E', 'F', 'G', 'I', 'N', 'M', 'V', 'X', '3', '6', '\*'), or
- Sent Reason Code = ('AU', 'CS', 'ES', 'MR', 'NA', 'PI', 'PP', 'PS', 'TS')

Note: In this category of validations, there is not a check to ensure that the Sent Reason and How Received Reason for each student are matching, only if one exists.

For each reporting period, there is a range of dates where a student must be reported with a Student Standing (FS) record, and there is a range of dates where reporting the FS record is optional. Errors which involve mandatory reporting of FS records will be flagged as Critical, which must be corrected prior to the end of the reporting period. Errors which involve optional reporting of FS records will be flagged as Informational, which may be corrected but are not required prior to the end of the reporting period. The following table should be used to determine the mandatory and optional reporting situations.
