

EMIS Change 25-39

This change adds the Local Use Identification Code to the Student Demographic (GI) Record. As part of this change the EMIS Student ID Number Element definition is being slightly updated.

The EMIS Student ID Number Element is included on several records. Going forward, the valid options and reporting instructions will only appear in EMIS Manual Section 2.2. All other EMIS Manual sections that include the EMIS Student ID will refer to Section 2.2. The marked-up element text from EMIS Manual Section 2.3 Student Demographic–Race Detail (GJ) Record is included below. These same updates will be made to all other sections that include this element.

Definition	The locally determined EMIS student ID, used primarily to connect records during EMIS reporting.

Valid Options

Nine-digit ID used by the school district

Reporting Instructions. The EMIS ID is the district-determined number that is used by districts for student tracking. This number uniquely identifies each student within the district. The school district is responsible for assigning this number. The EMIS student ID number ~~is for local use only~~ [is primarily used to connect records during EMIS reporting. It and](#) is not submitted to the Department, [but may be used in ODDEX as a student identifier if a Local Use Identification Code \(GI610\) is not reported for a student.](#)

Local Use Identification Code

<u>Record Field Number</u>	<u>GI610</u>
<u>Definition</u>	<u>The ID students are known by within the district. Typically, this is the ID teachers have and that would be shared with a student’s parent or guardian.</u>

Valid Options

Up to 9 contiguous characters; can be letters or numbers or a combination

Reporting Instructions. The Local Use Identification Code is the ID that is used locally. Typically, this is the ID that teachers use and that is shared with parents. Districts are not required to report this identification code. If not reporting a Local Use Identification Code for a student, then report all spaces.

If reporting these codes, they cannot look like social security numbers. If the codes reported could be social security numbers, they will not be submitted to ODDEX. In such cases, it will appear within ODDEX as though the district chose not to report this element.

If these codes are not 9 characters long, include spaces at either the beginning or end of the code. For example, an ID code of “A38C2” can be reported as either “ A38C2” or “A38C2 ”.
