Report Overview

General Description and Significance

This report lists all of the districts in OEDS, indicating whether a district is closed or open, and showing the status of files that are expected to be sent to ODE. It allows districts to be assured that data has been processed by ODE and incorporated into the appropriate files. It will also indicate files that may not be required to be submitted to ODE.

Note: This report in no way describes the completeness or correctness of the data. If even a single record for a particular file type is submitted, the submission of that file type is noted on this report.

This report contains the reporting status of all districts in all ITCs. It is distributed to each ITC during every week of the processing cycle.

Note: For the February reporting period entities may be listed on the report that do not need to submit any data during the February reporting period.

Tips for Reading This Document

- EMIS data elements are written in SMALL CAPITAL LETTERS.
- Report field names are written in BOLD SMALL CAPITAL LETTERS.
- Options (values) for each data element are indicated in *ITALICIZED CAPITAL LETTERS* and are enclosed in quotation marks.
- Record names are displayed in *italicized bold letters*.
- File names are displayed in CAPITALIZED BOLD LETTERS.
- CCYYP denotes the century and year and processing period.

Report Name and Timing

The file name for the report is: EMIS_MISSING_PERCCYY.PRT. The PER in the title names the EMIS reporting period and the CCYY names the fiscal year of the report. This report is produced during every EMIS reporting period.



ODE Processing

Process Description

This report is generated based on the intake of the EMIS files from the ITCs. As each submission set is evaluated and determined to have a correct header, footer, and at least one data record, this information is written to the AUDIT file. The AUDIT file contains data from the current week and all preceding weeks of the current processing cycle and the report is generated from it.

Report Selection Criteria

Districts that appear on this report are determined by their OEDS values:

- OEDS District Type = "0","1","2","3","4","G","H"
- OEDS Status = '1','2','8'

The values of the flags under each column of the report are determined by the sort type and sub type of the records that were successfully submitted. The determination of the *, A, N, or NS flags is based on the reporting period requirements and the district's profile.

Report Sample

Header Information

The header lines identify the report, tell when the report was created, and include a key for identifying the flags under each column heading.

That is followed by column headers indicating the data described on each detail line.

Detail Information

- The OBS column is a SAS element, numbering each district found for the report.
- The CLOSED column contains "*" when the OEDS district type = "2"
- District IRN
- District Name
- County in which the district is located
- List of file types expected to be submitted to ODE. The flag under each file type is determined by the successful acceptance of a district's data. These flags may vary for the same district from one reporting period to the next based on the requirements of that reporting period and the profile of the district.

0	"Y"	Data received and processed
0	"NS"	Data not received by ODE
0	"N"	Data not received by ODE, but may not be needed
0	"A"	Data not received by ODE and impacts accountability
0	"AC"	All data impacting accountability has been submitted
0	"*"	Status not applicable, data may not be needed for reporting period

Note: When an "N" or "*" show in a column it indicates that the district will **not** be on the Data Accountability Missing List for that file. For the February reporting period community schools may see "N" or "*" for all records, this means that they will may not need to submit any data for February and they will not show up on the data accountability missing list.



- The ITC abbreviated name
- The indicator as to whether or not all accountability data files have been received. Note, again, that this flag only tells the district that at least one of the records for each one of the files was processed by ODE. It does not give an indication of the completeness, correctness, or integration of the various types of files.

February Report Period:

Since only some community schools are required to report during the February reporting period and some districts may not be required to submit all records for February reporting, the list below indicates what record types that we require for the entities indicated:
