This program generates a report for FTE and Funding Source information of Special Education Staff within a district. Each non-JVS school district, except DYS, DRC, and State Board districts, will receive a report. It is distributed to each district that submits data in the October (K) week-end process.

This report allows the district to see what data about special education staff are currently recorded in the EMIS system.

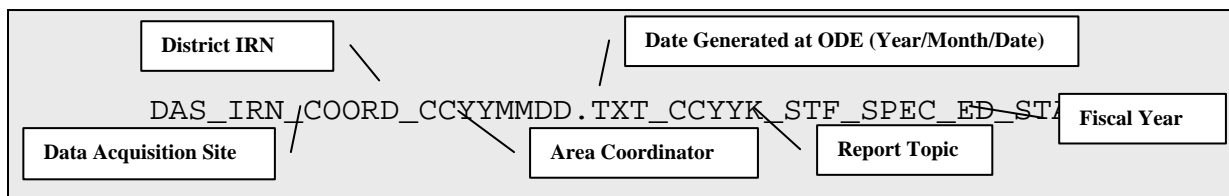

- Report field names are written in **BOLD SMALL CAPITAL LETTERS**.
- Options (values) for each data element are indicated in *ITALICIZED CAPITAL LETTERS* and are enclosed in quotation marks.
- Record names are displayed in *italicized bold letters*.
- File names are displayed in **CAPITALIZED BOLD LETTERS**.
- CCYYYP denotes the century and year and processing period.

Report Name and Timing

ODE Processing

Process Description

The program that produces this report is run during the weekly EMIS process. It is not dependent on aggregations. However, the certification process should be run before this program to ensure that the certification flags are properly set.

Data Source

The **STAFF EMPLOYMENT** file is the main driver of the report program and **OEDS** and the **STAFF DEMOGRAPHIC** data are used in the report output. This report no longer uses extraneous files of allowed and approved units; all of the outputs are a result of data submitted by the district or calculations within the report-generation program.

There are no derived data used in this report.

Report Selection Criteria

The first filter will include Staff Employment records if

- POSITION TYPE (CK140) = “*R*” and
- TYPE OF APPOINTMENT (CK150) = “*I*” or “*3*” or “*4*” or “*5*” and
- POSITION FTE (CK100) > “*0*”

Once records have passed through that filter, they will be included if

POSITION CODE = “*318*”, “*325*”, “*326*”, or “*327*” and

POSITION STATUS = “*A*”, “*C*”, “*D*”, “*I*”, “*N*”, “*O*,” or “*R*”

or

The third tier of filters ensures that the POSITION CODE and ASSIGNMENT AREA are logically connected and that the POSITION STATUS is an allowed one:

POSITION FUND SOURCE not = spaces or "Z"

And one of the following

POSITION CODE = "110" or "113" and ASSIGNMENT AREA = "999400", "999401",
"999406", "999583", "999584", "999630", or "999725"

or

POSITION CODE = "206" and ASSIGNMENT AREA = "999402", "999404", "999405",
"999407", "999409", "999410", "999411", "999412", or "999413"

or

POSITION CODE = "318" and ASSIGNMENT AREA = "999455" and
POSITION STATUS = "C", "D", "N", "O", or "R"

or

POSITION CODE = "318" and ASSIGNMENT AREA not = "999455" and
POSITION STATUS = "A", "C", "D", "I", "N", "O," or "R"

or

POSITION CODE = "212", "304", "325", "327", or "328", or "333"

or

POSITION CODE = "326" and ASSIGNMENT AREA = "999741" or "999742"

The criteria for adding FTE to position description subtotals are:

EDUCATION LEVEL = "1", "2", "3", "4", "5", or "6"

And one of the following

POSITION CODE = "212" and POSITION FUND SOURCE not = "Z"

or

POSITION CODE = "206" and POSITION FUND SOURCE not = "Z"
ASSIGNMENT AREA = "999402", "999404", "999405", "999407", "999409",
"999410", "999411", or "999412"

or

POSITION CODE = "318"
ASSIGNMENT AREA = "999455"

or

POSITION CODE = "110" or "113" and POSITION FUND SOURCE not = "Z"
ASSIGNMENT AREA = "999630", "999406", "999401", "999400", "999725",
"999584", or "999583"

or

POSITION CODE = "326" and POSITION FUND SOURCE not = "Z"
ASSIGNMENT AREA = "999741", "999742"

or

POSITION CODE = “304”, “327”, “328”, or “325” and POSITION FUND SOURCE not = “Z”

When the approved units was printed on the report, the program ensured that only happened when the staff member was properly certified. The certification check is irrelevant for printing the FTE value.

Report Sample

Header Information

The first area of the header describes information about the report generation. The upper left section names the program from which the report was generated and the data source. The middle information identifies the producer of the report and the report title. The upper right section states the date on which the report was generated, the page number, and the reporting period to which the report belongs.

The second area of the header pertains to the recipient of the report. It identifies the district for which the report was produced, its IRN and COUNTY, the ITC and AREA COORDINATOR of the district.

That is followed by column headers indicating the data described on each detail line.

Detail Information

There are two distinct sections to this report: the first lists each special education staff member and the second totals the FTE by the position description. Each section has a different output line.

In the staff listing section, the fields in each row are:

STATE ID#	from the <i>Staff Employment</i> EMPLOYEE ID
NAME	from the <i>Staff Demographic</i> EMPLOYEE NAME
POSITION DESCRIPTION	Hard coded in program, abbreviated ASSIGNMENT AREA description, see Appendix B, <u>EMIS Manual</u>
TOTAL FTE	calculated as described below
FUNDING SOURCE	from <i>Staff Employment</i> POSITION FUND SOURCE

The **TOTAL FTE** is computed as follows:

POSITION FTE is multiplied by the decimal representation of each FUND SOURCE PERCENT. If there is more than one FUND SOURCE, there will be a product for each; these are added together to get the final FTE for a single staff member.

If the calculated FTE is greater than “1”, the excess is added to a running total of excess FTE and the **TOTAL FTE** value is changed to “1”, i.e. the **TOTAL FTE** can never be greater than one.

There may be more than one Position Fund Source for a staff member. If that is the case, they are reported in the following order: “U”, “L”, “Z”, “A”, any other code.

There may be more than one detail line listed for a staff member. Staff may have multiple employment records with positions that have different Local Contract codes, possibly in different buildings, with each record accurately reflecting the FTE and the work hours that apply to each job record.

In the listing by position, the fields in each row are:

POSITION DESCRIPTION	Hard coded in program, abbreviated ASSIGNMENT AREA description, see Appendix B, <u>EMIS Manual</u>
TOTAL FTE	computed as a running total of each staff POSITION CODE.

Error Detection and Correction

If the district finds any discrepancies between the reported data and their expected results, the following data fields should be verified:

EDUCATION LEVEL	CI100

An incorrect entry in any one of these fields may cause a staff member to be excluded or misrepresented on the report.

If there is more than one detail line for a specific staff member, verify that the FTE is correct for each position listed. The FTE on the staff member detail line of the report is NOT a total of all staff employment records for that individual. It reflects the data that are applied to a specific job record, each with its own Local Contract code, accurate building IRN, FTE, and work hours.
