

LEVEL 1 CURRENT ENROLLMENT HEADCOUNT SUMMARY AND CURRENT ENROLLMENT HEADCOUNT DETAIL REPORT EXPLANATION

The Report

The Current Enrollment Headcount Summary Report is a summary of student headcount and summarized percent of time by various groupings as reported by the district. The report includes students reported as of the most recent Data Collector Prepare that meet the selection criterion specified below. The groupings are Overall Enrollment, Grade level, Received Reason, and Sent Reason.

The Current Enrollment Headcount Detail Report is the detail data that is used to create the Enrollment Summary Report and has additional information that the district may find useful in doing data verification or for the district's own use.

These reports allow the district to see enrollment information on students enrolled as of the date the report is generated. These reports are being provided to the district for general use in data verification and for the district's internal use. It is not appropriate to use these reports for any type of funding FTE comparison.

The reports include students who are enrolled as of the date listed on the report and do not include any students who withdrew prior to that date or enrolled after that date.

The Selection Criterion

The selection criteria for the Enrollment Detail Report include students reported by the district who meet the following criteria:

- A Student Standing (FS) Record with an Effective Start Date that is less than or equal to (\leq) the date listed on the report
- A Student Attributes – Effective Date (FD) Record with an Effective Start Date that is less than or equal to (\leq) the date listed on the report

Students are *excluded* from the report when

- The student withdrew before the date listed on the report
- The student enrolled after the date listed on the report
- The student has a Fatal error or Dependency error

Current Enrollment Headcount Summary Report Sample

Summary reports have aggregate counts by district and building for traditional districts and by Building for community/STEM schools. Records are sorted by IRN, Student Grouping, District Relationship, and Student Grouping Value.

Headcount is simply a count of unique student IDs at the time the report was run. The Total % of Time/100 is the sum of the three Percents of Time (Student Percent of Time + Sent 1% + Sent 2%).
