- All districts that have students in the collection are expected to continue submitting data
- Exiting students with a disability group revisions anticipated
- Grad Follow-Up Value level 2 report in the works

Alternate Assessments

- Collection open Feb. 9 Aug. 4, 2023
- Assessment Type
 - -Grades 3-8 (GA)
 - –High School (GX)
- Missing list reminder: "Other Participating Assessments" column
 - Links to Grades 3-8 and EOC missing reports





Other Accountability Assessments

- Collection open Feb. 9 Aug. 9, 2023
- Assessment Type
 - Industry Credentials (GW), International Baccalaureate (IB),
 Scholastic Aptitude Test (SA), American College Testing (AC),
 Advanced Placement (AP), ACT WorkKeys (WK)
- Missing only includes SAT and ACT
- (ICAC-001) Industry Credential Administrative Conflict
 - Checks for multiple entities reporting student credential and Required Test Type IPD for same student





Career Tech Accountability Assessment

- Collection open Feb. 9 Aug. 4, 2023
- Assessment Type
 - –CTE Technical Assessment (GY)
 - –Industry Credential (GW)
- Missing list based only on GY vendor file
- (CTAC-001) CTE Accountability Program of Concentration Tech Assessment Results
 - -Based on current year CTE course enrollment or
 - -Current or prior year CTE assessment reporting
- (ICAC-001) Industry Credential Administrative Conflict





Spring End of Course Assessment

- Collection open Feb. 23 July 19, 2023
- Assessment Type End of Course Tests (GE)
- Missing list reminder: "Other Participating Assessments" column
 - Links to Grades 3-8 and Alternate missing reports



Spring State Assessment Grades 3-8

- Collection open Feb. 23 July 19, 2023
- Assessment Type Ohio's State Tests (GN)
- Missing list reminder: "Other Participating Assessments" column
 - Links to EOC and Alternate missing reports



Child Outcome Summary (COS)

- Collection open Oct. 20, 2022 Aug. 25, 2023
- All students with disabilities required to be assessed
- Resident district reports
- Assessment Type Child Outcome Summary (GM)
- Include Test Day of the Month (FA212)
- Missing report
 - Students can appear on wrong district's report if educating district points to wrong district of residence
 - -Corresponding Gen Issues IS0491





When to Administer and Report COS

- At least once per year
- When student enters special education preschool
 - -Within 30 calendar days of eligibility determination
- When student exits special education preschool
 - -Within 30 calendar days of exiting special education
- Two results should be reported if student enters and exits within same year with at least 6 months between





Early Learning Assessment

- Fall collection closes Mar. 31, 2023
- Spring collection open Apr. 20 Aug. 25, 2023
- Reporting requirement depends on funding source
 - –ECE program = entity receiving funds
 - -PSE program = resident district
- Assessment Type Early Learning Assessment (GB)
- Missing reports for student enrollment and vendor results during respective test windows
- One appeal in August for both collections





DPR Growth Assessment

- Collection open Oct. 20, 2022 July 19, 2023
- Assessment Type Star Assessment (GD)
- Reduce unified scaled score by 500 points prior to upload to Data Collector
 - -Department will add back in
- Include Test Day of the Month (FA212)



OELPA

- Collection open Jan. 26 Aug. 4, 2023
- Assessment Type Ohio English Language Proficiency Assessment (GF)
- Required for foreign-exchange students identified as English learners
- Missing report based on
 - -Enrollment
 - -EL status
 - -Vendor file
- FY23 ALT-OELPA results will not be reported until FY24



Assessment Group DN Attributes

- For reporting start date of district's administration window if different from state administration start date
- Currently, three attributes
 - -ASMTFG3ELA = Fall 3rd Grade ELA assessment
 - -ASMTSPRELA = Spring English Language Arts
 - All grades, including EOC
 - -ASMTSPRMSS = Spring Math, Science, Social Studies
 - All grades, including EOC
- Used in generation of missing lists for respective collections





Grad Cohort Assignment





Data Used to Assign Cohort

- State Equivalent Grade Level (FD090) as of Oct. 1 for student reported in the prior year
- Fiscal Year that Student Began Ninth Grade (FN110) for student not reported in the prior year
- Based on data reported in regular Student (S) Collections
 - Data reported in the SCR Collection does not include FD and FN Records

Example: State Equivalent Grade Level

- Reported in FY22 with State Equivalent Grade Level = 08
- Reported in FY23 with State Equivalent Grade Level = 09 for the first time by Oct. 1

FS/FD Effective Start and End Dates	Cohort Assignment Outcome			
Includes October 1	2026 assigned in FY23			
After October 1	Cohort assigned in FY24			





Example: Fiscal Year that Student Began Ninth Grade

- Student not reported in prior year
- Transfers into district from out of state
 - -Student placed in grade 10
- Fiscal Year Student Began Ninth Grade = 2022
 - -Assigned to 2025 cohort





Early Grads

- Students who graduate early will count in their originally assigned cohort
- Must meet graduation requirements of the assigned cohort

Cohort Reports Recommendations

- Verify students listed in each cohort
- Determine if any students are missing from each cohort
- Confirm students should be included in district's denominator
- Use to verify accountability





(GRAD-002) Newly Assigned to Grad Cohort


- Use to verify first year students
- Focus on ADD COHORT BY GRAD EVENT CODE column
 - -GRDIN: Placed in cohort based on reported state equivalent grade level
 - –FYB9G: Placed in cohort based on reported fiscal year began 9th grade
- Make corrections before close of FY23 End of Year Student (S) Collections





Grad Cohort Tab – ODDEX

- Includes data reported by other districts
- Useful in determining why a student is or is not included in cohort and grad rate





Access to Grad Cohort Tab

- Users with these roles can view and export data within the module
 - -Superintendent
 - -Coordinator-EMIS
 - -Director-EMIS
 - -Supervisor-EMIS
 - Data View-ODDEX Records GRAD
 - -Site Manager (ITC only)
 - -SDC-Student Level Access (ITC only)
- OEDS Roles for ODDEX Access index: ODDEX Help





FY23 Graduate Cohort Appeals

FY23 Graduate Cohort Required to Approve: Superintenden (instructions) Appeal Opens: Oct. 16, 2023 Appeal Closes: Oct. 27, 2023 FY23 Data Included Impacted Organizations Graduate Reporting: Only Fiscal Year Began » Districts Ninth Grade OR Grade Level Element » Community schools » STFM >> Deadline to submit corrected data in EMIS for approved appeals is Nov. 10.





Appealable Data

- Can update Fiscal Year that Student Began Ninth Grade and State Equivalent Grade Level
- Must use the FY23 Graduate Cohort Data Appeal form available in OH|ID
 - -Can include 2023 cohort or beyond
 - -Cohorts will not be changed for any finalized grad rates





Gifted





Reporting Requirements

- Traditional districts, community schools, and STEM districts must report Student Gifted Education (GG) Record for each student K-12
 - -Even if not screened or assessed
- JVSs do not report
- Educating entity reports in shared student situations





Traditional District Requirements

- Required to screen, assess, and identify
- Not required to serve
- If served, report accordingly
- Validation checks verify Gifted Served (GG510-GG570)
 matches Gifted Identification (GG430-GG490





Community School & STEM Requirements

- Not required to screen, assess, identify, or serve
- If screened, assessed, identified or served, report accordingly
- Validation checks verify Gifted Served (GG510-GG570)
 matches Gifted Identification (GG430-GG490)



Report As Screened

- If given an approved assessment as part of whole-grade testing
- If nominated or referred
- If screened independently and scores provided by parent
- ACT and SAT automatically considered screened for any grade level in following subjects
 - –ACT = Math, Reading/Writing, and Science
 - -SAT = Math and Reading/Writing
 - Exception: Community schools not providing services would not report as screened

Report As Assessed

If additional testing is given to determine giftedness when screening results are inconclusive


-Usually, same year as screening





Report As Identified

- If statutory identification threshold met
- If identified at prior entity
 - Once identified, always identified
- Using original Gifted Identification Date (GG430-GG490)
- If ACT/SAT threshold scores met
- By Mar. 31 to be included in current year report card
- Identification info in ODDEX History Flag Order:







Report As Served – via Courses

- Student Population (CN340) option
 - –GA = Gifted education In Arts Delivered By Trained Arts Instructor K-12
 - -GE = Gifted Education K-12
- Gifted education credential required for GE courses
 - -Position Code (CK060) = 230
 - -Assignment Area (CK220) = 999380
 - –Not required for courses with Student Population = GA
 - Can be a trained arts instructor





Report As Served – via Services

- Student Program (GQ) Record
- 206xxx range with Employee ID
 - -Provided by gifted intervention specialists
- 205xxx range
 - -Not provided by gifted intervention specialists





(FTED-006) Partial Gifted FTE

- Level 2 report for newly identified students partially funded for gifted
- All student's FTE records display
 - –May have multiple data rows
- Identification date included

Gifted Gen Issues

• IS0350-IS0356

-Greater than 10% change in students identified in each area of giftedness from one year to the next

• IS0357

-Greater than 10% change in served students from one year to the next

• IS0462

- Lack supporting data for students reported as served
- -No courses or program codes reported





EMIS Changes





FY23 Changes

23-134: Disability condition 16 can be reported for students aged 3-9 regardless of grade level

-Once age 10, an option other than 16 must be reported



FY24 Changes

- Additional changes now out for public comment
 - –24-61: Clarify program code 221005 Coordinated Early Intervening Services reporting
 - -24-58: Clarify ELA and COS reporting guidance
 - -24-48: Clarify EL Status reporting guidance
 - -24-41: Changes to Acceleration record
 - -24-27: Student Contact information reportable by all LEAs


