ASSESSMENTS

END OF COURSE ASSESSMENT

- Summer and Fall collection open Sept. 21, 2023 – March 21, 2024
- Spring collection open Feb. 22 – July 17, 2024
- Assessment Type (FA060) = GE (End of Course Tests)
- Spring missing report
 - Based on enrollment, course enrollment, and vendor file
 - Includes “Other Participating Assessments” column
 - Links to Grades 3-8, Alternate, and OELPA missing reports

KINDERGARTEN READINESS ASSESSMENT (KRA)

- Collection open Sept. 21, 2023 – Feb. 16, 2024
- Assessment Type (FA060) = GO (Kindergarten Readiness Assessment)
- Missing report based on enrollment and vendor file
- Supplementary report will display second year students reported with current year results

CHILD OUTCOME SUMMARY (COS)

- Collection open Oct. 19, 2023 – Aug. 23, 2024
- All students with disabilities required to be assessed
- Resident district reports
- Assessment Type (FA060) = GM (Child Outcome Summary)
- Include Test Day of the Month (FA212)
- Missing report
 - Based on enrollment
 - Students can appear on wrong district's report if educating district points to wrong district of residence
 - Corresponding Gen Issues IS0491
- Gen Issues IS0476 compares prior year scores reported to current year

DPR GROWTH ASSESSMENT

- Collection open Oct. 19, 2023 – July 17, 2024
- Assessment Type (FA060) = GD (Star Assessment)
- Reduce unified scaled score by 500 points prior to upload to Data Collector
 - Department will add back in
- Include Test Day of the Month (FA212)
- Missing report based on enrollment and vendor file

READING DIAGNOSTICS

- New collection open Nov. 16, 2023 – July 17, 2024
- Assessment Type (FA060) = RD (Reading Diagnostic)
- If KRA used, do not report results in **this** collection
 - Results are reported in the Kindergarten Readiness Assessment Collection

TIER 1 DYSLEXIA SCREENER

- New collection open Dec. 14, 2023 – July 17, 2024
- Assessment Type (FA060) = DS (Tier 1 Dyslexia Screener)
- Missing report based on enrollment

OELPA AND ALT OELPA

- Collection open Jan. 25 – Aug. 7, 2024
- Assessment Type (FA060) = GF (Ohio English Language Proficiency Assessment)
- Required for students identified as English learners
- Missing report
 - Based on enrollment, English Learner (EL) Status (FD170), and vendor file
 - Includes “Other Participating Assessments” column
 - Links to Grades 3-8, Alternate, and EOC
- In FY24, the results from FY23 ALT-OELPA can be reported (24-14)

ALTERNATE ASSESSMENTS

- Collection open Feb. 8 – Aug. 7, 2024
- Assessment Type (FA060)
 - GA (Grades 3-8)
 - GX (High School)
- Missing report
 - Based on enrollment and vendor file
 - GX assessment type only includes grades 11 and 12
 - Includes “Other Participating Assessments” column
 - Links to Grades 3-8, OELPA, and EOC

OTHER ACCOUNTABILITY ASSESSMENTS

- Collection open Feb. 8 – Aug. 9, 2024
- Assessment Type (FA060)
 - GW (Industry Credentials), IB (International Baccalaureate), SA (Scholastic Aptitude Test), AC (American College Testing), AP (Advanced Placement), WK (ACT WorkKeys)
- Missing report
 - Based on enrollment and vendor file
 - Only includes SAT and ACT
- (ICAC-001) Industry Credential Administrative Conflict
 - Checks for multiple entities reporting industry credential with Required Test Type of IPD for same student

CAREER TECH ACCOUNTABILITY ASSESSMENT

- Collection open Feb. 8 – Aug. 7, 2024
- Assessment Type (FA060)
 - GY (CTE Technical Assessment)
 - GW (Industry Credential)
- Missing report based only on GY vendor file
- (CTAC-001) CTE Accountability Program of Concentration Tech Assessment Results
 - Based on current year CTE course enrollment **or**
 - Current or prior year CTE assessment reporting
- (ICAC-001) Industry Credential Administrative Conflict

SPRING STATE ASSESSMENT GRADES 3-8

- Collection open Feb. 22 – July 17, 2024
- Assessment Type (FA060) = GN (Ohio’s State Tests)
- Missing report
 - Based on enrollment and vendor file
 - Includes “Other Participating Assessments” column
 - Links to Alternate, EOC, and OELPA

ASSESSMENT GROUP DN ATTRIBUTES

- For reporting start date of district's administration window if later than state administration start date
- Three attributes reported in student (S) collections
 - ASMTFG3ELA = Fall 3rd Grade English Language Arts
 - ASMTSPRELA = Spring English Language Arts
 - ASMTSPRMSS = Spring Math, Science, Social Studies
- Used in generation of missing reports for respective collections

THIRD GRADE READING GUARANTEE (TGRG)

READING IMPROVEMENT AND MONITORING PLAN (RIMP) PROGRAM CODES

- Report only if plan meets **all** requirements **and** is implemented
 - 151505 – Summer intervention
 - 152700 – 152750 regular school year intervention
- Reported for students in grades K-4 (24-104)
 - Will continue to include additional grade levels annually
- EMIS Change 24-99 removed codes 152755 and 152760
- Use other Academic Intervention codes if all RIMP requirements not met
 - 151490 – Academic Intervention, Summer
 - 152330 – Academic Intervention, Regular School Year

RETENTION/PROMOTION – GRADE 3 ONLY

- Beginning in FY25, parent can request promotion to fourth grade regardless of promotion score
 - Adds new Retained/Promoted Status (FN070) option (25-24)
- All other retention/promotion options still valid
 - * = Met required promotion score on 3rd Grade English Language Arts assessment
 - 1-4 = Retained/promoted for reasons other than TGRG
 - 5 = Met promotion score on TGRG Alternative Assessment, retained for other reasons
 - A = Retained at end of previous year due to TGRG, still retained
 - D-G = Not retained, met one of the exemptions
 - H = Retained at end of previous year, no longer enrolled
 - J-N = Not retained, met promotion score on TGRG Alternative Assessment

GRAD COHORT ASSIGNMENT

COHORT ASSIGNMENT

- Determined by data reported in student (S) collections
- State Equivalent Grade Level (FD090) as of Oct. 1 for student reported in the prior year
 - If after Oct. 1, cohort assignment occurs following year
- Fiscal Year that Student Began Ninth Grade (FN110) for student **not** reported in the prior year
- Assignment errors can only be corrected with regular reporting in the first year

COHORT REPORTS REVIEW RECOMMENDATIONS

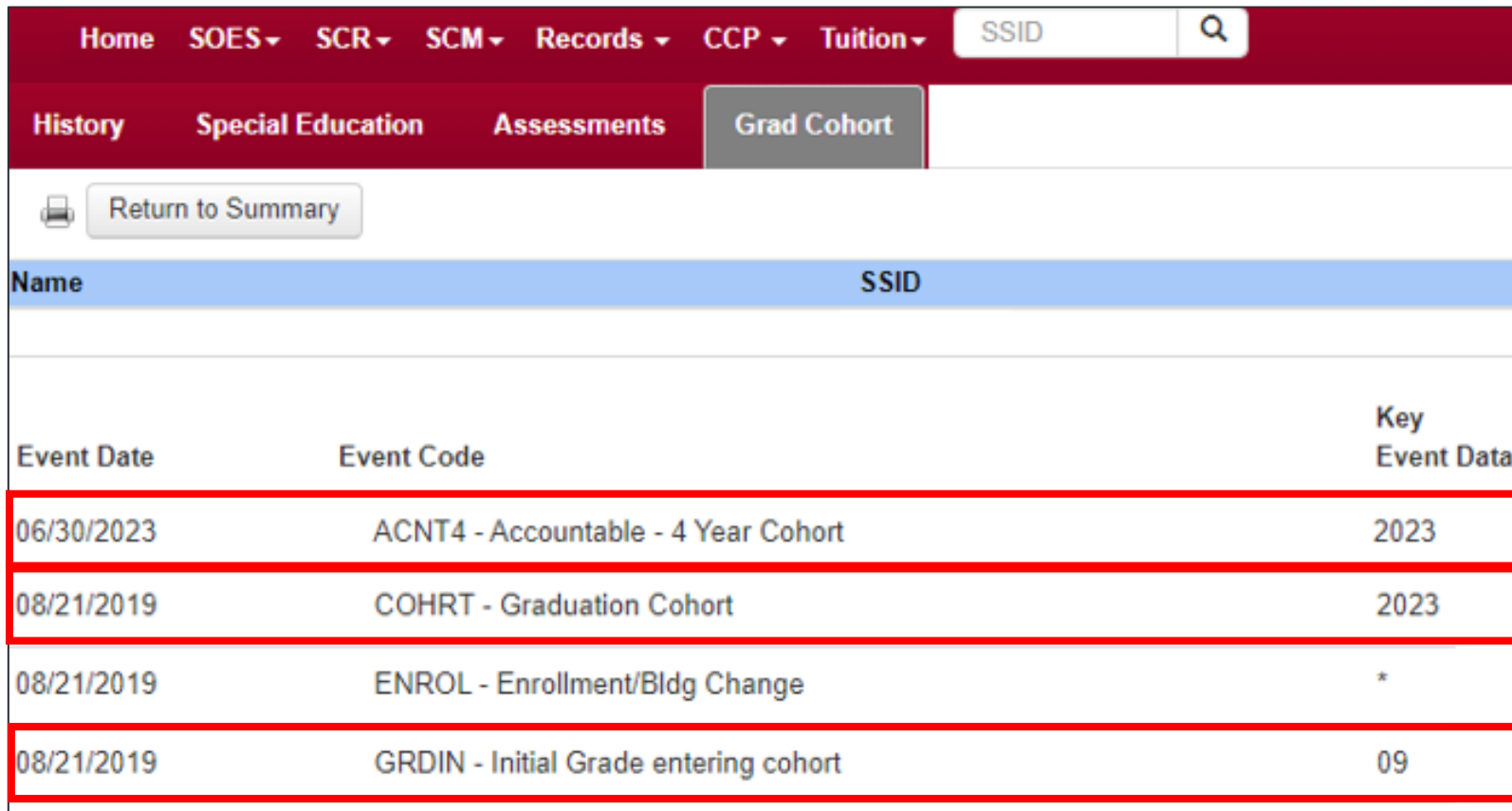
- Verify students listed in each cohort
- Determine if any students are missing from each cohort
- Confirm students should be included in district's denominator
- Use to verify accountability

(GRAD-002) NEWLY ASSIGNED TO GRAD COHORT

- Use to verify first year students
- Focus on ADD COHORT BY GRAD EVENT CODE column
 - GRDIN: Placed in cohort based on reported state equivalent grade level
 - FYB9G: Placed in cohort based on reported fiscal year began 9th grade
- Make corrections before close of FY24 End of Year Student (S) Collections

GRAD COHORT TAB – ODDEX

- Includes data reported by other districts
- Useful in determining why a student is or is not included in cohort and grad rate

EMIS CHANGES

CTE AT OHIO TECHNICAL CENTERS (OTCS) (24-101)

- Delivery Method (CN320) = TC (CTE course delivered at an OTC)
 - All other course reporting the same as for any other contracted situation
 - Staff Provider IRN (CU120) = *****
 - Location IRN (CN110) = per approved CTE-26
- If total enrollment between JVS/district and OTC is greater than full time
 - Sent Reason (FS200, FS230) = TC (Student attending a CTE course at an OTC)
 - Sent To Percent of Time (FS220, FS250) = greater than zero
 - Attendance required

FY25 CHANGES

- Many open for public comment now
- Public comment dates TBD = still in the works
- 25-29: Report CORE Fine Arts Requirement Met (FN250) with Y for exempt students
 - Can be used for FY24 reporting
