- The Individuals with Disabilities Education Act (IDEA) is a federal law that makes available free appropriate public education (FAPE) to eligible children with disabilities and ensures special education and related services to those children
- NIEP Date Type (GE100) option was created for the purpose of
  - Demonstration of services provided based on prior Individual Education Plan (IEP) while the next IEP determinations are made
  - Inclusion in Federal Child Count (FCC) if in place by Oct. 31
  - Generation of state weighted special education funding



## **REPORTING CRITERIA**

- Student must have had a prior IEP
  - Regardless of prior IEP being reported
- Student must be receiving special education services based on the prior IEP



## **NON-COMPLIANCE ID (GE130) OPTIONS**

- 10 Student newly transferred in; IEP adoption determination not complete; services being provided based on prior IEP
- 11 IEP expired; new IEP not in place; services being provided based on prior IEP
- 12 IEP current, but not reported to EMIS in prior collection; services being provided based on current IEP

#### • Student Attributes – Effective Date (FD) Record

Element	Option
Disability Condition (FD130)	Same as prior/current ETR



- Out-of-state transfer
  - ETR expired
  - IEP expired

#### • NIEP is reportable

  - Current ETR
  - Current IEP
- NIEP reportable

- In-state transfer
  - Initial ETR completed
  - Student transfers before initial IEP meeting
- NIEP not reportable because *no prior IEP*
