- Data Conversion
 - Moving data from legacy database
 - FY06 to FY10 data done
 - FY11K done; running FY11N today
 - Once legacy data moved, several database updates to be made

- Enhancements
 - Progress monitoring
 - What step in the process when
 - Where at within a step
 - Scheduled collections
 - Off-hours collection
 - Kick off prepare automatically
 - "Fresh" data and reports at the start of the day
 - More powerful previews/reports

- Performance
 - Changes to the Data Collector
 - Changes to the collection requests
 - TSG work with each ITC
 - Optimize hardware configurations
 - Optimize software settings
 - Standardized performance test
 - User feedback when waiting/working

- ODE "backend" processes
 - Some processes redone from scratch
 - Certification checks
 - Preschool units
 - Some have nearly no changes
 - Funding calculations
 - Career Tech reports
 - Likely take 2 more years before all redone

Pre-Launch Activities

- Training/Test Manifest
 - ITC based
 - Manifest available to practice functions in system
- Security
 - LEA Collector
 - LEA Reviewer
 - LEA Submitter
- Email Notifications

Flat File vs. SIF

- No student information via SIF for October, but may be multiple by yearend
- USPS/USAS via SIF
- SLF/SSID via SIF

Frequency of Submission/ODE processing

- Once per day to start
- Specific time TBD, but late afternoon most likely
- Time will be when submission has to be complete, not started
- Over time, hope is to process multiple times per day

Rollout schedule

- October 3- Five Year Forecast- due 10/31
- Between 10/3 and 10/14- K collection released
 - Will give one week heads-up
- Between 10/31 and 11/4- K data to ODE
 - Begin level 2/post processing
 - Reports roll out through December
- K closes on January 25 (Wed)

Reports

- Everything has a new home
- Multiple Types
 - Level One
 - Level Two
 - Post Processing
- Ability to manipulate csv files in Excel or another program will give benefits

- In the Data Collector
- Run on demand based on latest collection, even if data not sent to state
- Grid-style reports- columns and rows of data
- Can be exported as CSV for analysis

Level Two Reports

- Run when data loaded at ODE
- Sent back at least once a day
- Cross-district and/or cross-year
- Updated even if you do not resubmit
 - New errors can be added
 - Errors can go away
