

Ohio Revised Code §3301.0730

- Requires the Department to create a process by which users of EMIS can review and provide public comment on new or updated EMIS Guidelines
- Starting in FY22, certain EMIS changes must be posted on the web in the spring for 30 days for public comment
 - -Allow 30 days to respond to comments
 - -Another 30 days of public review before considered "final"
 - -Total of 90 days

Timeline

- Changes subject to public comment started being posted on a rolling basis starting April 2, 2021
- These first set of FY22 changes will go into effect July 1
- FY22 EMIS Manual will be posted in early July

Tier 1 Changes – Policy

Included in public comment process, subject to spring deadline for posting

- New or updated data element, reporting option, reporting instruction that changes what districts are required to report (substantive) <u>driven by a policy decision</u>
- Change in which organization type is required to report existing data

Tier 2 Changes – Legislation

Included in public comment process, but *not* subject to spring deadline for posting

- -Newly enacted state or federal law
- –New or updated federal rule
- Rule or resolution adopted by the state board of education

Tier 3 Changes – Data Quality

Not included in public comment process, **not** subject to spring posting deadline; the following are some examples

- New/updated reports generated from EMIS
- Report explanations
- Non-substantive updates in EMIS Manual (e.g., correcting grammatical errors and unforeseen technical errors)
- -Clarify implementation of EMIS guidelines
- –Answer EMIS questions
- -Provide training and related materials

- Share implementation plan with stakeholder groups

 - –EMIS trainings
 - -EMIS Newsflash

FY22 EMIS Changes Posted for Public Comment

Ohio Revised Code Section 3301.0730 requires EMIS to create a process by which users of the system can review and provide public comment on new or updated EMIS Guidelines. EMIS changes that are subject to this process must be posted on the website for 30 days for public comment, 30 days for the Department's response to comments, and then another 30 days for public review before changes are considered "final".

Changes that are open for public comment are included on the FY22 Changes webpage and can be identified by a red short title. These changes also include the relevant comment and review dates and an attachment with the details of the change. To submit comments about a change, use the email link listed for that change. Each email link is unique to the particular change. Please do not include comments for multiple changes in a single email.

The first set of FY22 changes subject to this process have been posted. The public comment period for these changes opened on April 2 and closes at the end of the day on May 1. Student was not retained at the end of the previous school year. Includes all 3rd grade students promoted to 4th grade who received the required promotion score on any administration of the state 3rd grade reading assessment before the start of the next school year and 3rd grade students who were promoted under the flexibility provided in House Bill 409.

Student was retained at end of the previous school year for reasons other than the Third Grade Reading Guarantee and is still retained and 3rd grade students who have been retained in the 3rd grade because the principal and reading teacher agree the student is not reading at grade level and is not prepared for 4th grade (as outlined in House Bill 409).

Retained Status Reporting Instructions

Reporting Instructions. This element is only reported for students in Grade 3. Report the option that best describes the student's retention status as of the first day of the current school year.

Report option "*" for students who have met the reading requirements in the Third Grade Reading Guarantee and have not been retained.

Report "*" for students who did not meet the regular assessment promotion threshold and did not meet any of the Alternative Assessment (options "J"—"N") or exemption criteria (options "D"—"G"), but are still being promoted to 4th grade under House Bill 409 flexibility.

Report options "D"-"N" if they apply and the data is available.

Report option "5" for students demonstrating adequate performance on a Third Grade Reading Guarantee Alternative Assessment who are retained for other reasons.

 - Attributes to be added to the DN Record to collect this information

SCR Demo Fields Required

New check to make sure all SCR demo fields are reported

- –In FY21, additional fields were included as part of the Student Cross Reference Collection, but students were not fataled from that collection if the fields were not included
- –In FY22, a student will fatal in SCR if any required field is not included on the GI Record
 - New fields were GI090 Summative Racial/Ethnic Group and GI270 Native Language

Any changes required from the budget bill

Tier 3 Data Quality, 1

- Reminder: no public comment period for tier 3 changes; however, feedback is always welcome on reports, checks, and other process improvement or documentation ideas
- Add DN attribute for First Day Test window to assessment missing reports (22-8)
 - -Related to EMIS changes 20-94 and 21-68
 - Applies the update for Spring 3-8 and Spring EOC
- Add CTAC-102 and -103 Level 2 reports to the Beginning of Year Student Collections (22-13)

Tier 3 Data Quality, 2

- Open Student Course Grade Collection earlier in the fall (22-10)
 - –In the fall, the progress towards graduation and early warning systems are planned to be operational
 - -To ensure that all the relevant data can be updated by LEAs, this change would move the open date for the Student Course Grade Collection earlier
 - Does not impact EMIS Manual
