  - 77 Withdrew due to 3314.26 (non-tested 2 year e-school)
  - 38 Student promoted beyond max grade
  - 81 Student reported in error- never should have been reported
  - 39 Non-enrolled no longer receiving services
  - 79 Reason for enrollment (received reason) no longer valid

- Admission Reason Additions
  - A: Student previously enrolled by the Board of Regents (BOR) - only used by BOR
  - B: Student previously enrolled in an Ohio K-12 education program- only used by BOR
