



Count of students in the four-year graduation cohort








HOW ARE STUDENTS PLACED IN A COHORT?

Based on first year reported in any public-school Grade 9 or higher using one of the following:

- State Equivalent Grade Level
- Fiscal Year that Student Began Ninth Grade

High School Dropouts

 WITHDRAWAL REASON = Withdrew Due to Truancy/Nonattendance, Pursued Employment/Work Permit, Over 18 Years of Age, Moved, Student Completed Course Requirements but did NOT pas the assessments required to graduate, Non-Attendance According to the 72 Hour Rule, Withdrew due to ORC 3314.26 (non-tested), Withdrew due to non-attendance at internet-based community schools, and no longer eligible to be enrolled in District

Non-graduates

• WITHDRAWAL REASON = Not Applicable

Transfer In

• Enrolled in District during HS

Reinstated Transfer

• WITHDRAWAL REASON = Transferred to Another Ohio School District however, no admission in an Ohio school reported



REMOVED FROM DENOMINATOR

Students Reported in Error

• WITHDRAWAL REASON = Never should have been reported

Transfer Out

• WITHDRAWAL REASON = Transferred to another school outside of Ohio, another Ohio school, home education, by court order or adjudication, or out of the United States

Students who are deceased

• WITHDRAWAL REASON = Death





experience education through work, about work and for work.





COMPLETION OF A PRE-APPRENTICESHIP

The Pre-Apprenticeship program teaches basic technical and job-readiness skills for a designated apprentice occupation or sector to prepare students for a formal Registered Apprenticeship training program.

Must be ApprenticeOhio-recognized pre-apprenticeship program



ACCEPTANCE INTO AN <u>APPRENTICESHIP PROGRAM</u> POST HIGH SCHOOL



Apprenticeships offer the chance to gain skills that will lead to a higher salary and great job opportunities. Apprenticeships are available in a variety of occupations, including health care, internet technology, advanced manufacturing, and construction.



Once completed they receive a certificate that is recognized nationally. The completed program must be registered with ApprenticeOhio.



COMPLETION OF AN <u>APPRENTICESHIP</u>




THIS MEASURE INCLUDES STUDENTS WHO ARE 16 OR OLDER WHO COMPLETED THEIR APPRENTICESHIP PROGRAM BY MEETING THE MINIMUM ANNUAL 2,000 HOURS OF ON-THE-JOB TRAINING AND 144 HOURS OF CLASSROOM INSTRUCTION THEY WILL HAVE RECEIVED A CERTIFICATE OF COMPLETION THAT IS RECOGNIZED NATIONALLY. THE COMPLETED PROGRAM MUST BE REGISTERED WITH APPRENTICEOHIO

The 21st century workplace constantly is evolving. To ensure success in their careers, students must be prepared to engage in this rapidly changing environment. Ohio businesses are seeking talented workers who have solid academic skills such as reading, writing and mathematics, as well as the professional skills required for success in the workplace. Among these professional skills are being reliable, drug free, disciplined and able to solve problems.

Ohio's education system must support students in acquiring the professional skills that

Ohioans need to be job-ready. When schools prepare students for the 21st century workplace, they also build the talented workforce that Ohio businesses need.

ALTOINESS SER

Established under <u>section 3313.6112</u> and are reported with at least 250 hours of work-based learning experience

Students work with at least three experienced and trusted mentors who validate the demonstration of these skills in school, work, or the community.

REPORT ONLY MEASURES

ACT Participation

• Percentage of the 4-year gradation cohort students that sat for the ACT test. A student must be reported with a valid score in all sections of the ACT listed above to be counted as a participant and thus included in the numerator

SAT Participation

 Percentage of students that took the SAT test. A student must be reported with a valid score in all sections of either version of the SAT listed above to be included in the numerator

AP/IB Participation

 Percentage of students that took Advanced Placement or International Baccalaureate assessments. AP or IB tests taken no later than October 31 of the cohort graduation year are included


College Enrollment and Graduation

Data from the National Student Clearinghouse Research Center is used to calculate the percentage of students enrolling in college within 2 years and graduating from college within 6 years. In order to allow sufficient follow-up time, enrollment in college rates are for the Class of 2020 and graduation from college rates are for the class of 2016.



Post-High School Pathways

Data from the Exiting Student Follow-Up Collection provides additional information on the various paths students take after leaving high school. These data are based on all students who graduated in 2022.



Federal Student Aid


The Federal Student Aid Office publishes the number of students completing the Free Application for Federal Student Aid (FAFSA).
