## Answers to the Scenarios:

## Scenario 1: Regional Level

- 1. How many elementary schools are identified as CSI schools in SST Region 10?
- 2. How many schools are identified as ATSI in SST Region 3 for Students with Disabilities?
  - a. As a follow up, what is the total number of ATSI schools in SST Region 3 (regardless of sub-group)?

 How many TSI schools are in SST Region 2 and which subgroups are they identified for? <u>Answers S1</u>:

- 1. 2021 2022 Data: Five CSI Elementary Schools in SST Region 10
- 2. 2021 2022 Data: Four ATSI Schools for SWD
  - a. Eight ATSI schools
- 3. For 2022 2023: Five TSI Schools (1 Black, 2 ED, 1 SWD, and 1 White)

Scenario 2: District Level - Akron City (IRN 043489) and Cincinnati Public Schools (IRN 043752)

- 1. Does Akron City have a school/s that have exited CSI status? If so, how many?
  - a. Where did you go to see if Akron City had schools that exited?
- 2. Does Cincinnati have a school/s that is *eligible* to exit CSI status? If so, how many?
  - a. Where did you go to see if Cincinnati has a school/s eligible to exit CSI status?

- 1. Five CSI Schools Exited

- 2. Six CSI Schools Eligible to Exit

<u>Scenario 3:</u> School Level - Cincinnati - Robert A Taft IT High School (IRN 036830) and Constellation - Old Brooklyn Community Middle (IRN 000321)

- 1. What is the federal identification status for Robert A Taft, and what was their cut score for the year they were identified?
  - a. Which report card components contributed to their overall rating score?
- 2. What is the federal identification status for Constellation Old Brooklyn Community Middle? Hint: Which subgroup has been identified?
  - a. Which report card component made up the majority of their overall rating score for their identified subgroup?

## <mark>Answer S3</mark>:

- 1. CSI School for Lowest 5%. The overall rating score for Robert A Taft was 1.00, which was below the cut score of 1.15 for all CSI schools in 2021 2022.
  - a. Four Components: Gap Closing, Achievement, Graduation Rate and Progress.

- ATSI School for SWD. The overall rating score was 0.95 for the SWD Subgroup for Constellation Old Brooklyn Community Middle School, which is below the cut score of 1.15 for 2021 – 2022.
  - a. Progress Component.
