

2024 CCWMR DISTRICT DISTRIBUTION





Even though there appears to be a very different distribution for buildings, this is due to the **One district: Many buildings** ratio. Over 75% 1-star buildings are in a 1-star district. Across all star levels, 94% of buildings have the same or higher star rating than their district.

PERFORMANCE AND LEVEL OF IMPROVEMENT (EFFECTIVE 7/1/2025)

The rules shall specify that a district or building shall not receive **lower than a performance rating of three stars** for the component if the district's or building's performance on the component meets or exceeds a **level of improvement set by the department.**”

Level of Improvement

- Only applicable to districts/buildings who have an initial rating of under 3 stars
- Level of improvement set at 15 percentage points







WHO COUNTS IN THE FOUR-YEAR ADJUSTED GRADUATION COHORT?

- **Graduates:** Withdrawal Reason = '99'
- **High School Dropouts:** Withdrawal due to Truancy, Pursued employment, over 18 years of Age, Moved not known to be continuing, completed course requirements but did not pass appropriate testing to meet graduation requirements, nonattendance according to 72-hour rule for community schools, withdraw due to ORC 3314.26 or 3314.261 and No longer eligible to be enrolled in District. Withdrawal Reason = '71', '72', '73', '74', '75', '76', '77', '78', '79'
- **Non-Graduates:** Withdrawal Reason = '*'
- **Reinstated Transfer:** Students who were withdrawn stating they were going to another Ohio school , but no Ohio public school reported enrollment. Withdrawal Reason = '41' however, no admission in an Ohio school



WHO IS REMOVED FROM THE FOUR-YEAR ADJUSTED GRADUATION COHORT?

- **Students Reported in Error:** For example, students who enrolled but never attended. Withdrawal Reason = '81'
- **Transfer Out:** Student transfers to another school district outside of Ohio, another Ohio public district, to a private school, homeschooling, by court order or adjudication or transferred out of the United States. Withdrawal Reason = '40', '41', '42', '43', '45', '46'
- **Deceased:** Withdrawal Reason = '52'



HOW ARE CERTAIN GRADUATES COUNTED?

EARLY GRADUATES

- Early graduates count with their Graduation Cohort (i.e., if a student began 9th grade in the fall of 2020 and graduated in the spring of 2023, they would count in the 2024 Graduation Cohort)
- Early graduates have until their anticipated graduation date to show post-secondary readiness.

“SUPER SENIORS”

- Grade 13 or 23 students must demonstrate post-secondary readiness by their 4th year in high school.
- Anything earned after the 4th year of high school is not included in the calculation.





Example: Evergreen Local accidentally reported 12pt Industry Recognized Credential records for 10 students with a non-passing score (N). As a result, those students did not contribute points to the component. Depending on prior year's percentage, possible increase to 3 Stars.

COLLEGE, CAREER, WORKFORCE, AND MILITARY READINESS

The College, Career, Workforce, and Military Readiness (CCWMR) component measures how prepared the graduating class from a district or building is as they transition to post-secondary education, enter the workforce, or join the armed forces. The readiness of a graduating class is estimated by calculating the number of students that achieve one or more of the component measure goals.

The College, Career, Workforce, and Military Readiness component **WILL NOT** be rated or included in the overall rating for schools and districts until the 2024-2025 school year at the earliest.

Data collections and business rules have not been finalized for this component. All currently available data for each measure will be reported and a preliminary component percentage displayed but this data should be considered for informational purposes only.

- Are the students who earned WBL showing up as expected?


