# Post-Program Outcomes

Post-Program Outcomes component looks at the proportion of students who are employed, in an apprenticeship, join the military, enter a service program, or are enrolled in postsecondary education or advanced training in the six months after leaving school. Industry credentials measures the proportion of students earning industry credentials before they leave high school, or in the first six months after leaving school.

## **Purpose**

Indicates the reliability and validity of Post-Program Placement performance results.

---

## **Calculation**

Status Known Rate affects the final rating for the Post-Program Outcomes component.

---

## **Demotion/Promotion**

Less than 85% known rate results in a star demotion; 95% or more known rate results in a star promotion.

# ***WHAT DOES THE POST-PROGRAM PLACEMENT RATE MEASURE?***

## **Purpose**

- Evaluates the CTE Concentrators who left secondary education who are employed, in apprenticeships, in the military, enrolled in postsecondary education, or undergoing advanced training within six months of high school

## **Reporting**

- Data is lagged to allow time for collection and reporting through the Exiting Student Follow-up

## **Calculation**

- Only includes students for whom status is known





# ***UNDERSTANDING CTE PERKINS V CONCENTRATORS***

- CTE Perkins V Concentrators are secondary students
- They complete two Workforce Development courses
- Identification is based on course completion
- Concentrators can exist before program completion
- Courses may span different LEAs and years
- Early concentration is possible before 9th grade

# ***UNDERSTANDING CONCENTRATORS WHO LEFT SECONDARY EDUCATION***

- Concentrators who are no longer enrolled in secondary education
- They may have graduated or dropped out
- They are not just those who completed concentration in the prior year or “completers”
- Students who were CTE concentrators in more than one LEA during their secondary education are only included in the follow-up file of the LEA and program of concentration in which they were most recently a CTE concentrator

# EXITING STUDENT COLLECTION

## Follow-up List Includes

CTE student who met concentrator status and who left secondary education the prior year

## Follow-up File Excludes

CTE Concentrators reported as having left secondary education the previous year who are enrolled in an Ohio public school prior to the exiting student follow-up collection in the current year

## Required to Follow-up

Data must be reported for each student in the extract

# ***INCLUDES***

---

Includes any CTE Concentrator (in the follow-up file) if they meet the following conditions:

- **Transferred to Another Ohio School District:** If they did not appear in the other district file in the subsequent year
- **Withdrew:** Due to Yoder vs. Wisconsin<sup>1</sup>, Truancy/Nonattendance<sup>1</sup>, or ORC §3314.26 (non-tested)
- **Pursued Employment:** Obtained a work permit
- **Over 18 Years of Age:** No longer eligible to be enrolled in the district
- **Moved:** Not known to be continuing
- **Completed Course Requirements:** Met high school graduation requirements
- **Non-Attendance:** According to the 72-Hour Rule

# ***EXCLUDES***

---

Excludes any CTE Concentrator who is enrolled in the current year, as reported in district enrollment data, by the close of the Initial Student (S) Collections in EMIS2. Excludes any CTE Concentrator in the following categories:

- **Withdrawn:** In the prior year (including summer withdrawals) if they appear in another district
- **Transferred:** To Another School District Outside of Ohio, Private School (includes Ed Choice), Home Education, or by Court Order/Adjudication
- **Moved:** Out of the United States
- **Death**

# TIMELINE FOR CTE FOLLOW-UP



- Initial follow-up occurs after student exit.
- Placement questions asked during the 2nd quarter.
- Data must be reported during Initial Follow-Up Collection.
- Final data collection does not affect accountability.

# POTENTIAL IMPACT ON POST-PROGRAM OUTCOME RATING

Example: Evergreen Local is part of a Compact CTPD with one other district. Evergreen Local did not report follow-up data for 30 concentrators during the Initial Follow-up Student Collection. As a result, the CTPD receives a demotion to the status known rate.

This component is crucial for understanding the effectiveness of career-technical programs in preparing students for the workforce or further education.

# ***REQUIRED OEDS ROLES AND SECURITY PROCESS***

- To obtain access to the Secure Data Center (SDC) a user must be assigned either the **Secure Data Center – Standard Level Access** *or* **Secure Data Center – Student Level Access** roles in [OEDS](#)
  - \*\*Either role will grant the user access to student-level data within the reports
- Security is now based primarily on the IRN as the driver.
  - When logging into the Report Portal system, users will be prompted to select from one or more IRNs to view reports
  - For example, users may be assigned access (via the OEDS SDC role) at the District IRN, School IRN, or a combination of both
  - Users with access to data from multiple IRNs must select the highest level in their hierarchy of access (i.e., District level) to view reports for the entire district










